OFSTED Report

We were inspected in November 2011 and everyone was delighted that we were awarded the inspection grade 'Good'.

Here is an excerpt from the main findings of the 2011 Ofsted report:

Park Street provides its pupils with a good education. Their attainment is above average and rates of progress are good. Pupils enjoy coming to school.

Attendance is high and this is a key contributory factor in pupils' learning.

The school's curriculum leads to pupils' good personal and academic outcomes. Recent curriculum innovation has led to increased opportunities for pupils to use their basic skills in other subjects so that learning takes place in a relevant context. The curriculum now features theme days and weeks more frequently and there is much greater use of outdoor areas.

Good levels of care, guidance and support are evident for every child and are a strength of the school. Partnerships with other professionals ensure that those who have special educational needs and/or disabilities or whose circumstances may make them vulnerable are well supported. This support has a positive impact on their self-esteem and confidence. Pupils' contributions in lessons are valued and this helps to foster a positive, learning ethos throughout the school. Pupils' spiritual, moral, social and cultural development is good and they show respect for each other's differences. Adults and pupils relate well to each other and these constructive relationships contribute well to pupils' personal development and well-being.

Our Creative Curriculum

We work hard to ensure that our curriculum motivates all children to want to learn and achieve their full potential. In order to do this we teach much of the National Curriculum through topics which engage our children's interest. These topics change and develop to meet the needs of our children. An example topic might be 'The Great Fire of London' and the children would undertake a number of activities in relation to the topic including: Learning about the history of the fire, the geography of the area, they might construct houses of the period, write a diary like Samuel Pepys and produce a newspaper article reporting on the fire, look at artists' depiction of the event and paint their own pictures. They might be taught the skills needed to research this period using computers or how to make a Powerpoint presentation of their findings.

We find that our pupils become so enthused by this means of learning that they will often freely carry on with their learning at home and then bring it back into school to share with us.

Of course there are some subjects like phonics, spelling, maths, religious education, physical education, personal, social and health education, French (for Key Stage 2) and sometimes music which will usually be taught separately from our topics.

Children should not arrive at school before 8.40 a.m.

Punctual arrival by children by 8.55 a.m. is important in learning good life habits and to get the day off to a positive start for themselves and their class.

In assembly we learn about Christian values which we also get in our newsletter.

Time Out After School Club

The After School Club is shared by How Wood and Park Street Schools and was set up by 'Time Out' staff Karen Chesterman and Angie Kay-Jessop in January 2010.

The aim is to provide a happy, safe, fun and stimulating environment for the children. It is registered by Ofsted and operates in a large log cabin on the How Wood School site.

The Club is staffed by a Manager or Deputy Manager with play workers and runs term time only from 3.15pm - 6pm. It is open for all children from the age of 4 – 11years.

Park Street School children are collected from the school and supervised on the short walk to How Wood School by Time Out staff on Tuesdays, Wednesdays and Thursdays.

Although based in the log cabin, it also uses outside areas as much as possible to play football, basketball, tennis, cricket, parachute games or just sit and have some quiet time in the fresh air. A 'high tea' is provided.

Children from Year 4-6 can attend Breakfast Club providing they have permission from their parent/carer to walk to school by themselves.

School Uniform

Boys Grey school trousers or shorts. White polo shirt with school logo Burgundy School Sweatshirt with school logo Grey socks. Sensible black shoes. Girls Grey Skirt or Pinafore. White polo shirt with school logo Burgundy School Sweatshirt or Cardigan with school logo White knee socks or grey, black or white tights. Girls are allowed to wear grey school trousers if they wish. They must be similar to those worn by boys, tailored with a zip either at the front or the side. Pink and white checked school dresses in summer (Y5 &Y6 girls optional summer wear: Grey skirt with white blouse or polo shirt). Sensible black shoes.

School burgundy sweatshirts and cardigans, outdoor jackets, white polo shirts and PE Tee shirts are available from Stevensons School Uniform in St Albans or *www.stevensons.co.uk*

P.E. Kit

All children are expected to change fully for PE. Burgundy shorts (not cycling shorts) Sky blue Tee Shirt with school logo Plimsolls or Trainers Jogging bottoms

All children need a named P.E. kit bag to be kept in school. School kit bags are available from the office: highly recommended.

Please ensure that all items of clothing are clearly marked with the child's name.

No jewellery may be worn in school. The only exception to this is that girls who have pierced ears may wear simple studs. These must be removed for P.E. lessons. Boys are not allowed to wear earrings of any kind in school.

Bands, ties and scrunchies for hair should be plain and in one of the school colours – burgundy, pink, white or grey. Any child with shoulder length hair, or longer, needs to have it tied back. Shapes, lines etc shaved into hair are not allowed.

SUPPLEMENTARY INFORMATION FORM for admission to Reception in 2016-2017

DETERMINED ADMISSIONS POLICY FOR ENTRY INTO THE MAIN SCHOOL IN 2016/2017

Park Street School is a Church of England Primary School and Nursery, linked with Holy Trinity Church, Frogmore. If you would like to know more about the school, please ask for a prospectus or telephone for an appointment to visit the school.

Responsibility for admissions lies with the School Governors. It is their policy, where possible, to admit to the school all children whose parents would like them to come and who are happy to accept the definite Christian ethos of the school.

To apply for a place at this school you must either apply on-line at <u>www.hertsdirect.org</u> or complete the Common Application Form from the Local Authority (Hertfordshire). You are also requested to complete the school's Supplementary Information Form (SIF). This can be found on the school's website or from the school office. Without the latter form the Governors will be unable to apply their criteria and your application, although valid may receive a lower ranking.

The School currently has a Published Admission Number of 30.

The Governors will offer a place to a child with a Statement of Educational Needs or Education, Health and Care Plan which names the school.

If the school is oversubscribed the Governors will apply the following admissions criteria:

- 1. Children who are or have been in the care of a local authority. This includes children who were looked after but immediately after being looked after became subject to an adoption, child arrangement or special guardianship order. (See Note 1)
- 2. Children who have a compelling medical reason attested by the child's Consultant which makes attendance at Park Street School essential.
- 3. Children with a sibling who will be enrolled in the school at the time of admission. (See Note 2.)
- 4. Children whose parents/guardians regularly worship at Holy Trinity Church, Frogmore and whose application is verified by the Vicar. (See Note 3)
- 5. Children who live in the ecclesiastical parish of Frogmore which includes Park Street, How Wood, Frogmore and Colney Street or the adjoining ecclesiastical parishes of St Stephens, St Peters, London Colney, Shenley, Radlett, Bricket Wood or Aldenham and whose parents/guardians regularly worship at any other Christian Church and whose level of attendance is verified by their Minister. (See Note 4)
- 6. Any other children.
- Note 1 The Children's Act 1989 defines a child who is 'looked after' as a child or young person who is accommodated by the local authority (Section 20) or a child or young person who is the subject of a full care order (Section 31) or interim care order (Section 38).

An 'adoption order' is an order under section 46 of the Adoption and Children Act 2002. A 'child arrangement order' is an order setting out the arrangements to be made as to the person with whom the child is to live under section 14 of the Children and Families Act 2014. Section 14A of the Children's Act 1989 defines a 'special guardianship order' as an order appointing one or more individuals to be a child's special guardian (or special guardians)

- Note 2 A sibling is defined as: the sister, brother, half brother or sister, adopted brother or sister, child of the parent/carer or partner or a child looking after or previously looked after and in every case living permanently in a placement within the home as part of the family household from Monday to Friday at the time of this application.
- Note 3 'Regular Worship' is intended to signify membership of and commitment to Holy Trinity Church, Frogmore. Parents are deemed to be 'regular worshippers' if they attend services at Holy Trinity Church; at least once a month; for the **12 months before the closing date for applications.**
- Note 4 'Regular Worship' is intended to signify membership of and commitment to a particular Christian Church. By 'Christian Church' we mean a local church or congregation in one location which is a member of, or is eligible for membership of Churches together in Britain and Ireland or the Evangelical Alliance. Parents are deemed to be 'regular worshippers' if they attend services at one specific church; at least once a month; for the **12 months before the closing date for applications.** The church must be named on the application form, and contact details given. In the event that there has been a change of church during the 12 month period, the applicants should provide the same information for the second church on a separate sheet. On receiving an application under this criterion, with church details supplied, the school will contact the church minister to check that this criteria has been correctly understood and applied.

It must be understood that an offer of a place is always subject to there being room in the Reception class. Where the application of the above criteria results in a situation where there are more children with an equal right to admission to the school than the number of available places, the tie-break will be the distance from the school measured using "a straight line distance measurement provided by Hertfordshire County Council's GIS system as outlined in the Moving On/Under 11s publications". Where distances are equal a tie breaker that involves names being picked out at random by an independent person will come into play. In the event of more applications than available places the Governors will maintain a continuing interest list (waiting list). These and late applications will go onto this list. If a place becomes available in the school it will be offered to the child that best meets the published admission rules at that time. All 'in year' applications will be managed by the LA on behalf of the

school, but a **SIF** is still requested. Parents are requested to inform the Governors if they wish their child's name to be removed. The Governors will maintain the list until the end of the academic year.

Parents who have not been allocated a place for their child in the Reception class have the right of appeal to an independent panel. Parents wishing to appeal who applied online should log on to their online application and click on the link 'register an appeal'. For those who did not apply online, please contact the Customer Service Centre on 0300 123 4043.

A repeat application within the same academic year will not be considered by the Governors unless there has been a significant change in circumstances.

The Governors cooperate with the LA in applying the Fair Access protocol for children who are hard to place in school.

Every effort will be made to accommodate twins and other 'multiple birth' applications. Where the 30th child admitted is a twin or multiple birth the other twin or sibling(s) will be admitted as exceptions to the infant class size rule

Parents of children admitted to nursery provision must apply for a place at the school if they want to apply to the Reception class. Attendance at the Nursery does not guarantee admission to the school.

Parents can request that the date their child is admitted to the school is deferred until later in the year or until the child reaches compulsory school age in that school year. For summer born children $(1^{st} \text{ April} - 31^{st} \text{ August})$ the start date cannot be deferred beyond the start of the summer term

Where a parent of a summer born child (1st April – 31st August) wishes their child to start school in the term following their fifth birthday, they will normally need to make an in-year application for a Y1 place. Parents should discuss this with the school as soon as possible. If parents wish such child to be educated "out-of year group" i.e. in the Reception Year rather than Y1 they should discuss this with the school. Such applications will be considered on a case by case basis. Parents do not have the right of appeal against a decision not to accept this request

Parents can request that their child attends part-time until the child reaches compulsory school age. The Governing Body is required to abide by the infant class size rule of a maximum of 30 pupils per class for 5, 6 or 7 year olds.
