Michael Brunner, Ph. D.

Michael Brunner, Ph. D., is a licensed psychologist and the clinical director of Fountain Centers, a Mayo Clinic Health System program serving communities in southern Minnesota. Dr. Brunner has worked and provided treatment to those with substance use and mental health disorders for over 13 years. He is most interested in the neurobiological causes and

consequences of addiction and aligning treatment interventions with brain-based impairments. Dr. Brunner received his doctorate from the University of Wisconsin-Madison and completed his post-doctoral fellowship at Eastern Virginia Medical School.



Shirshendu Sinha, MBBS

Shirshendu Sinha, MBBS, is a board-certified general adult psychiatrist and clinical fellow in addictive disorders at Mayo Clinic. He graduated from North Bengal Medical College and Hospital. He then traveled across continents and joined the dysproteinemia group as a post-doctoral research fellow at Mayo. He was impressed by the astounding success

of novel therapies that improve outcomes and quality of life among cancer patients. At the same time, he became aware of, and sympathized with, the frustrations and mental distress of patients with suffering from cancer and this distilled a keen interest in the field of psychiatry. He completed adult psychiatry residency training at University of Connecticut School of Medicine where he served as teaching/academic chief resident. His research and scholarly pursuits in various research projects have been highlighted in 15 peer-reviewed papers, the majority with Dr. Sinha as primary author. Additionally, he has authored more than 30 abstracts and presentations. He has contributed to the development of risk-stratified algorithm for the treatment of adult attention deficit disorder with stimulant medication while minimizing the risk of diversion. He has received awards from Janssen Academic Research Mentorship Program, American Society of Clinical Psychopharmacology, Neuroscience Education Institute and American Psychiatric Association. He is a member of the American Academy of Addiction Psychiatry's Youth and Adolescent Committee. After graduation he will join the outpatient psychiatry practice at Mayo Clinic Health System in Mankato.
