GINTC requires a waiver for each person who attends any of its events, including but not limited to FeatherFest and Holiday with the Cranes. You will be asked to agree to this waiver on the Terms and Conditions page if registering online, on this form for mail-in registrations or upon check in.

By my signature below, I agree that I have read and understand this statement and I recognize and acknowledge that certain risks of harm are inherent in the activities in which I have chosen to participate.

For and in consideration of my (or if participant is under the age of 18, my child) being permitted to participate in GINTC sponsored activities and the services provided as a result of participation, I agree, for myself (or my minor child), my (or his/her) heirs, executors, administrators, personal representatives and assigns, to assume all risks and responsibility for any and all damages or injury, including but not limited to personal injury or death, medical expenses, disability, lost wages, loss of earning capacity and property damages from any cause whatsoever which I (or my minor child) may incur or receive while participating in any GINTC sponsored activity.

I hereby agree to waive any and all claims, demands, damages, actions, causes of action, or suits at law or in equity of whatsoever kind or nature for or because of any matter or thing done, committed or suffered to be done by GINTC, its officers, directors, agents, employees and/or volunteers. I further agree to indemnify and hold harmless GINTC and its officers, directors, agents, employees and/or volunteers against any claims made by others for personal injury or property damage caused or contributed to by me (or my minor child) while participating in any GINTC sponsored activity. I also agree to follow all instructions in order to maintain a maximum level of safety. I believe that I am (or the participant is, if under the age of 18) in the proper physical and mental health to participate in the events chosen. I authorize GINTC and its representatives to take such action as seems appropriate to protect my health and physical well-being (or that of the participant, if under the age of 18). I also give my permission for any emergency medical care or treatment by a physician, surgeon, hospital or medical care facility that may be required as a result of injuries I (or my minor child) sustain while participating in GINTC sponsored activities, and I accept responsibility for the cost.

City of Galveston Personal Waiver of Liability

ARTWORK GUIDELINES & INSTRUCTIONS

- The artwork must be done on paper and be no smaller than 8" x 10" and no larger than 16" x 24". Photographs are accepted. No frames on any of the artwork.
- Entries are accepted beginning January 11. The deadline for submitting entries is February 12.
- All entries must be submitted via email.
- You will be notified via email by March 12 if your student's/child's work is chosen as a finalist in the contest. At that time, we will arrange for the finalists' artwork to be picked up for the final judging. Winners will be notified on April 1.
- Artwork will be judged by grade levels, arranged into 3 categories: 2nd – 4th grades, 5th – 8th grades, 9th – 12th grades.

INSTRUCTIONS FOR SUBMITTING ENTRIES

Please follow these instructions to submit your student's/child's bird or nature-related art on paper (including photographs).

1. Scan the completed application. Save the file as: Student's LastName_First Name.
2. Take a photo of your student's/child's artwork and upload it to your computer. Photos must be in JPEG format at 300dpi and at least 1800px by 1800px. Save and title the file: Student's LastName_FirstName_Grade
3. Complete and sign the waiver for student and accompanying adult.
4. Attach and send the application and waiver along with the photo of the artwork to artentry@gintc.org. The subject of the email should be: Student's Last Name, First Name, Grade Level. You will receive a confirmation within 24 hours via email that your submission has been received successfully.
