Stakeholders Celebrate First Phase of Corona Plaza Renovation

The Queens Economic Development Corporation and New York Community Bancorp joined local elected officials, residents and nonprofits to celebrate the first phase of the renovation of Corona Plaza on Sept. 13.

Located just south of the 7 Train's 103rd Street Station, Corona Plaza (known in the local community as "La Placita") is now a pedestrian haven with new seating, tables, umbrellas, bicycle racks and greenery. It has immediately become a magnet for people looking for a safe place to relax, eat, read, play and even enjoy a game of dominoes.

A second reconstruction phase with more improvements will start next year. The NYC Department of Transportation plans to carry out the next phase based on community input. Already made suggestions include permanent street furniture, flagpoles and a water fountain.

The revamp of this key commercial area has truly been a multi-faceted, community effort. With Borough President Helen M. Marshall's advocacy, the DOT included the site in its Plaza Program. With help from the Flushing Willets Point Corona Local Development Corporation, QEDC obtained financial commitments from New York Community Bank, the New York Community Bank Foundation and the Richmond County Savings Foundation. City Council

Member Julissa Ferreras secured funding to maintain the plaza, while Corona Community Action Now, a merchant group, was involved in every step.

Going forward, QEDC will participate in an innovative maintenance program with The Horticultural Society of New York and ACE, a local employment organization.

"New York Community Bank's support of The Corona Plaza Project allows us to reinforce our commitment to the Queens community in a tangible way," stated Joseph R. Ficalora, President and CEO of New York Community Bancorp. "This revitalized space will beautify an important small business hub and provide the people of Corona with a wonderful place to gather. We are proud to be able to help make this happen for the people of Queens."

"I am beyond pleased that the Corona Plaza project has finally gotten off the ground and the first phase is complete," stated Council Member Ferreras. "It has taken many years of hard work for it to come to fruition and I would like to thank all the community partners. The plaza is a beautiful addition to the neighborhood, providing a safe space for people to relax and children to play. Bringing this pedestrian plaza is part of my healthy community initiative, which will include fitness programming and a green market in the plaza for all to enjoy."

Borough President Marshall added: "I am happy to stand here today to support the next phase of renovation of Corona Plaza. Today's celebration of what has already been done and what will be done also provides a good opportunity to thank all of our partners in government and the private sector for their combined efforts to make Corona Plaza an attractive and open space for local residents."

"We are really excited about Corona Plaza," said QEDC Executive Director Seth Bornstein. "With this first phase, we already have a great public space that is business and people friendly, and it'll only get better after the second phase. We thank all those who helped us undertake this project and look forward to a great future.'

"Corona Plaza serves as a great public space that the community can call their own," added QEDC Neighborhood Development Director Ricardi Calixte. "This will be a place to socialize, dine and enjoy programs that celebrate the diversity of the people of Corona. This project beautifies the core of the Corona shopping district and brings pride to people that call Corona home.'

phases. The first phase, beginning September 2013, will take on approximately 120 students, and will be housed in a temporary location until the school is built some time in 2015. The principal of IS 61, Joseph J. Lisa welcomed the new school but expressed his concerns for this plan because it did not go far enough. Lisa stated that "over the past five years we have grown almost 400 students". He went on to say that the DOE plan expects IS 61 to house over 2200 students which will keep the school overcrowded. The School Construction Department lists IS 61 capacity as a little over 2000 students without being considered overcrowded. According the DOE proposal, this new school will hold approximately 800 students. Nick Comaianni, District 24 Community Education Council President, doubted DOE numbers by stating

that "we all know that it will be more like 900." Principal Lisa stated that we must do more and consider all options like middle school choice. He reported that in 2009 DOE officials stated that middle school choice would help give more flexibility to balance the numbers to deal with the overcrowded conditions at IS 61. Middle school choice was never enacted in District 24 and is one of the only districts not to have it. Councilwoman Julissa Ferreras urged the DOE to look at all options, "unfortunately many of our children grow up in overcrowded elementary schools and then go to an overcrowded middle school".

Up to this point the DOE has not addressed the enrollment growth at IS 61. Due to the growth, the DOE has decided to eliminate the Gifted and Talented program at IS 61. This has angered many parents and students at the school especially when it was reported in 2011 that there has been a reduction in the number of Black and Latino students entering specialized high school programs. IS 61 Parent Association Co-President, Alba Acosta, expressed her frustration at the DOE because they may have a plan for the future however she wanted to know what the DOE is doing for her son now. She did not understand why the Gifted and Talented program was being removed only punishing the school for being overcrowded. Assemblyman Francisco Moya emphasized that "we have to make sure that communities like ours are getting the resources that they deserve? and programs like the Gifted and Talented program should be protected. One student who graduated from IS 61's Gifted and Talented program, Jimmy Padilla, praised the program at IS 61 and urged that it remain. Padilla stated the school "is why today I am such a successful student."3

When Seniors Need Financial Assistance

When the last national census was taken in 2010, 48 percent of the population was classified as poor or low-income (earning less than 200 percent of the poverty level). Anyone who's ever tried to live on a low income knows how difficult it can be to make ends meet when cost increases for essentials like healthcare, housing, food and energy outpace their earnings. This can be especially challenging for seniors living on a fixed income.

The good news is there are literally thousands of federal, state and private assistance programs designed to help seniors and others cover their basic needs. Your challenge might be finding ones for which you're eligible. Here are a few suggestions:

The nonprofit National Council on Aging offers BenefitsCheckUp (www.benefitscheckup.org), a free, confidential web-based service that helps seniors and their caregivers find financial assistance for healthcare, housing, food, utilities, in-home services and much more. After answering several questions, you're issued a personalized report describing programs and services for which you may be eligible, including links to their websites and applications.

Several government-sponsored programs help people with limited income and resources pay for medical coverage, including Medicaid and Medicare. For a good round-up of these programs,

go to www.medicare.gov and click on "Get Financial Help."

Most pharmaceutical companies offer patient assistance programs (PAPs) that provide uninsured and low-income people access to prescription drugs they couldn't otherwise afford. Ask your doctor, pharmacist or health clinic for details. Other good resources include: Medicare's alphabetical list of drugs available through PAPs (www.medicare.gov/pap/ index.asp); Partnership for Prescription Assistance (www.pparx. org); RxAssist (www.rxassist. org); and NeedyMeds (www. needymeds.com).

In addition, as a result of the Affordable Care Act, Medicare Part D participants who reach the so-called doughnut hole coverage gap now receive a 50 percent discount on brand-name prescription drugs and a 14 percent discount on generics. (These discounts will gradually increase until 2020 when the doughnut hole will disappear altogether.)

The IRS tax code includes several benefits that target seniors (and often, other lower-income taxpayers), including:

• A higher standard deduction amount for most people who don't itemize deductions if they and/or their spouse are over 65 or blind.

• An additional tax credit for lower-income people who are over 65 or disabled and file a 1040 or 1040A tax form. (For full details and eligibility, see IRS Publication 524 at www.irs.gov.)

• Free tax return preparation assistance and counseling from

IRS-trained volunteers is available to people over age 60, as well as low-to-moderate income folks and military families.

• IRS Publication 554 provides comprehensive help for seniors to prepare their tax returns.

Many government-sponsored benefits, grants and financial aid programs exist to help seniors, low-income families and others pay their bills, including:

• LIHEAP (Low-Income Home Energy Assistance Program) provides grants to help pay utility bills. To see if you qualify, go to www.acf.hhs.gov/programs/ocs/ liheap.

• SNAP (Supplemental Nutrition Assistance Program) helps millions of lower-income Americans buy nutritious food each month. Visit www.fns.usda.gov/snap for qualification requirements.

• Rental assistance for lowincome families is available from several U.S. Department of Housing and Urban Development programs as well as other state and local agencies (see www.hud.gov/ renting/index.cfm for details).

• Go to www.usa.gov/Citizen/ Topics/Benefits.shtml for a comprehensive overview of additional aid programs.

And of course, don't forget to ask about senior discounts whenever you shop, travel or buy insurance -10 percent here and there can really add up.

Tonight is was Judy Collins. Having already seen her at the St. George Theatre in Staten Island, it made no difference. Her voice is still amazing. There are four people in the cast: Jacquelyn Piro Donovan, George Dvorsky, Anika Larsen and Sal Viviano. Music derives from two instruments - Piano (Andrew Gerle - Musical Director) and Bass (Danny Weller) who are at the rear of the stage. The set consists of 6 doors with props such as a table and chair that come on and off the stage. Now, you have the basic backdrop of the show.

"Closer Than Ever began as a file of observations about people David and I knew, stories friends and acquaintances told us about themselves, perceptions we had about our lives, which over time developed into songs. 



underway at Torsney Playground will include an eclectic mix of amenities for all residents of Sunnyside," said Council



New VA Policy Directive Will Deprive Vets With PTSD of Service Dogs That Help Them Cope & Recover

Calls On VA To Allow Their Doctors To Recommend Dogs To Vets That Need Them

U.S. Senator Charles E. Schumer today called on the Department of Veterans Affairs (VA) to immediately revise a recent directive that will prevent veterans with PTSD and other mental and emotional disorders from receiving VA benefits for service dogs. According to federal law, the VA can reimburse veterans with both physical and mental disabilities for the costs of owning a service dog, if a medical professional deems such a dog to be beneficial. However, according to a new VA directive that will go into effect on October 5th, only veterans with physical disabilities will have this option, until a VA study on the matter is completed in 2014. This is despite evidence that service dogs have the capability to assist those with mental disabilities. In the New York metro area, there are approximately 6,614 veterans who suffer from PTSD and are being treated at VA medical facilities or Readjustment Counseling Centers and 182,147 around the country.

Schumer was joined by Barbara Jenkel of Educated Canines Assisting With Disabilities (ECAD), and her dog Blip; Iraq veteran Charles Hernandez and his dog Valor; and Afghanistan veteran Leslie Wohlfeld and her dog Lizzy.

"Our veterans fought bravely on the field of battle, but unfortunately, for some veterans, the battle does not end once they return home," said Schumer. "Sadly, the horrors of war mean that many veterans come home with PTSD and other mental and emotional ailments. That's why we owe it to these vets to provide them with every recovery option possible, including service dogs, prescribed by a doctor, to help them heal. Man's best friend can be a vet's best friend, and that's why, as the wars are winding down and with the ranks of those suffering mental and emotional trauma remaining sky-high, the VA should not deny benefits to veterans that will help them to access service dogs."

Service dogs are trained dogs that offer assistance to people with disabilities. These dogs can be used to help people with visual, hearing or other physical ailments, as well as helping people with mental illnesses and emotional trauma. Mental health service dogs may help treat people with PTSD because they help them to cope with the everyday challenges including anxiety attacks, migraines and nightmares. There has been evidence to suggest that mental health service dogs can be trained to help avert panic attacks and remind veterans to take medication. The VA's new directive

eliminates service dogs as an option to treat mental ailments until an internal study is completed in 2014. The VA claims that they will not provide benefits for mental health service dogs to veterans with PTSD and TBI because there is not enough clinical evidence to support their effectiveness; however, there is overwhelming anecdotal evidence to support the effectiveness as well as a long history of providing service dogs people with mental disabilities. An essay printed in the U.S. Army's United States Army Medical Department Journal from April-June 2012, for example, explains the biology underlying the observed benefits of mental health service dogs for veterans suffering from PTSD. The article points to extensive anecdotal evidence of firsthand reports by veterans.

Mental Health Service dogs are also recognized as emotionally supportive in numerous agencies across the federal government. The Department of Justice, for example, recognizes mental health service dogs under the Americans with Disabilities Act. The Fair Housing Act allows tenants that have mental health service dogs stay in housing that would normally not allow pets, and the Air Carrier Access Act permits mental health service dogs to travel in the cabin when accompanied by a person with a disability. Furthermore, in 2009, Congress passed legislation (PL111-117) explicitly authorizing the VA to provide service dogs to mentally disabled veterans, including those with PTSD. But the VA not only has yet to do this, but this new directive will actually prohibit mental health service dogs as a covered treatment option for veterans.

Schumer, pointing to evidence supporting the use of service dogs to treat mental ailments, called on the VA to change course. He said that the VA's doctors and mental health professionals should be the ones that determine the best treatment for those with mental disabilities so that veterans with invisible wounds returning home get the assistance that they need. The VA's new rule specifically eliminates mental health issues as a qualification for obtaining benefits for a service animal. Schumer noted that clinical evidence may not be made available until 2014 or later, which is the earliest that VA's clinical study will be completed, and veterans who may benefit from mental



health service dogs may suffer before the science catches up to what is already known. Schumer also made the case that it is extremely difficult for veterans with PTSD and TBI to be able to cover the full cost of a service dog, which could cost tens of thousands of dollars. Schumer explained that it is a disservice to these veterans, who have fought for our country, to be denied the treatment they need. Even though VA only covers a portion of the expenses, it is a start that the VA should build upon.

Prior to this new VA directive, Congress pushed for the VA to begin researching the ways in which service dogs might be able to help veterans who suffer from the two most common mental disabilities from combat in Iraq and Afghanistan, PTSD and TBI and provide clinical evidence to suggest the effectiveness. The study is being conducted at the James A. Haley Veterans Hospital in Tampa, Florida and is supposed to take three years to be completed in 2014. Schumer said that while this study is underway, doctors and mental health professionals should still be allowed to recommend dogs for those with mental disabilities if they feel it will be beneficial.
