2. Manuscript Preparation

2.1. Paper and page number

The full paper must be 4, 6, or 8 pages.

2.2. Paper and font style

Space; Single-spaced. Font type; Times New Roman. Font size; 11. Paper size; A4 size (210 mm × 297 mm) if possible. Margins; 1" ×1"

2.3. Paper and font style

Manuscripts must be written in English. Authors whose native language is not English are recommended to seek advice from a native English speaker if possible, before submitting their manuscripts.

2.3.1. The title page should contain

- 1. Title,
- 2. Author(s)'s name(s); please indicate the corresponding author.
- 3. Full affiliation(s),
- 4. Abstract; approximately 200 words
- 5. Key words
- 6. A complete correspondence address, including a telephone number, fax number, and an e-mail

2.3.2. Tables and figures




Fig. 1. Font size of a figure title should be 10pt (bold)

- 1. Number as Table 1 (Fig. 1.), Table 2 (Fig. 2.) etc, and refer to all of them in the text.
- 2. Each table (figure) should be provided in the text closed to where it is referred.
- 3. Each table (figure) should have a brief and self-explanatory title with font size 10 (bold).
- 4. Color tables (figures) are available.

2.3.3. Equations

Equations should be carefully written and checked so that a compositor can follow its copy easily. Equation numbers should be Arabic numerals enclosed in parentheses on the right-hand margin. Please see the following example.
