

Payment Options

- Automatically by pre-authorized banking or credit card payment on or around the 25th of each month
- By internet/telephone banking or at most financial institutions

Late Payment Charge

If payment is not received by CityWest by the required payment date, it will be considered a delinquent amount and will be subject to a late payment charge of 1.25% per month(16.07% per year).

Billing

- Monthly services are billed one month in advance. Usage is alled in arrears. Service charges on your first invoice will be for the number of days in the first month that you were active.
- Customers who give CityWest reasonable advance notice (minimum 30 days) may terminate their service after expiry of the minimum contract period, which is one month commencing from the date the service is provided.
