

BARRICADE PROCEDURE AND FEES



BARRICADES

TEMPORARY NO PARKING barricades are intended to reserve the right-of- way for constructionrelated activities, residential moves, commercial moves, special events, community events, and filming projects. They are to be used for commercial vehicles (as defined by City code).

- Commercial signage on trucks must match the City issued permits on the No Parking plastic bags.
- Commercial trucks that do not have signs that match the City issued No Parking plastic bags, shall display the City Permit on the dashboard so that it's clearly visible.
- Passenger vehicles are not allowed in the reserved zone.

"NO PARKING" plastic bags are issued by, and obtained from, the City of Portland Development

Services Center. The permittee is responsible for placing the bags. Barricades, while recommended, are not required to place the city issued plastic bags and stickers, however they must be placed in such a manner as to be visible and readable from the street. (see photo)

Barricades, or equivalent, must be at the location/address to be reserved. When reserving more than one space, they should be placed as follows:

- 1. A minimum of five barricades per block face and no less than one barricade every 50 ft.
- 2. Adjacent to the parking lane, facing the street.
- 3. A barricade at each corner, if applicable.
- 4. Within a block face, outer most arrows (on the city issued bags with stickers) must point toward each other.

Temporary restrictions will supersede regular parking regulations only if all other parking signs are covered. Example: 1 hour or Truck Loading Zones signs, etc. must be covered within the barricaded area. Do not cover the 'No Parking Anytime' or 'No Stopping or Parking' signs.



VERIFICATION

The placement of barricades and/ or "NO PARKING" bags will be enforceable **24 hours after** Parking Enforcement verifies that they are installed correctly. All verification charges will be billed to the permittee.

VERIFICATION AND ENFORCEMENT FEES*

- \$60 for each verification and re-verification.
- \$60 for each enforcement request.**

One verification check by Parking Enforcement includes up to a

maximum of four (4) consecutive block faces (800 feet). (See page 2)

Verifications are valid for seven (7) calendar days from the date and time of the verification. If the job/operation is of longer duration than seven days, call Parking Enforcement once a week for re-verification.

The fee includes all vehicles illegally parked within the reserved zone if the permittee chooses to have Parking Enforcement verify the barricades.

Barricade verification is not required; however, if enforcement is needed and verification was not requested, refer to the Tow-by-the-Hour section of this form.

If a tow is necessary on Sunday or after hours, please contact Portland Police Non-Emergency at 503-823-3333 with the request.

METERED DISTRICTS

Under certain circumstances permits may be granted to temporarily reserve parking spaces, traffic lanes, sidewalks, and streets.

The device, installed by Parking Enforcement used to reserve the spaces, varies depending on the location of the spaces reserved. Delineators, bags or signs are used to reserve the space(s).

APPLICATION TIMELINE

Applications should be made a minimum of three (3) working days in advance of proposed work dates by contacting the Permit Center Transportation Counter in the Development Services Center at 503-823-7365.



TOW-BY-THE-HOUR

Tow-by-the-hour is an option for a permittee (or a representative) who has not met the 24-hour notice for verification by Parking Enforcement. Parking Enforcement will call a tow company to move the

vehicle to the closest legal space at the requestor's expense. **Before an officer is dispatched, the requestor must be on site and be prepared to pay the tower**. When calling for a tow-by-the-hour, the requestor will need to provide Parking Enforcement with:

- The name and billing address of the person/company requesting the tow.
- Location of vehicle and description (see request form).
- Permit Number.
- Parking Enforcement fees (see above), which are separate from the tow company's, will be billed to the requestor.
- The tow company's fees are separate from Parking Enforcement's fees. The requestor must have either cash or credit card at the site to pay the tower.

VERIFICATION EXAMPLES

One verification check by Parking Enforcement can include up to a maximum of four (4) consecutive block faces (800 feet). Below are some examples:
