

PORTS OF CALL PUERTO VALLARTA

For centuries, Puerto Vallarta was a sleepy fishing village. Then director John Huston chose the village as the location for his film "Night of the Iguana," starring Richard Burton. Puerto Vallarta was sleepy no more; its transformation into an international resort had begun. Lying just below the Tropic of Cancer, Mazatlan boasts a superb year-round climate. The climate, the beaches, and the world-class sportfishing have turned this commercial fishing port into one of the world's top resort destinations. Yet while visitors flock to the markets, bathe in the sun, or marvel at the airborne ballet of the famed Papantla dancers, Mazatlan remains one of Mexico's major Pacific ports - the city exports over 40 million pounds of shrimp every year.

CABO SAN LUCAS


