Instructions

Submit the completed application, payment in the form of a personal check, money order or cashier's check, and any required attachments to your local county tax assessor-collector's office. **Do not mail cash**. The Antique plate is issued for a five-year period to a qualifying vehicle. If the vehicle is to be registered to a vehicle that is not titled in your name, attach a statement to this application stating that you have legal right of possession and control of this vehicle at all times.

The fee is \$50 if the vehicle was manufactured in 1921 or later; the fee is \$40 if the vehicle was manufactured prior to 1921. Fees are prorated either \$10/\$8 each year or portion of a year remaining in the five-year period. Only one plate will be issued for display on the rear of the vehicle.

If you place your order by mail, please contact your county tax assessor-collector's office in three weeks to verify your plate is ready for issuance. Specialty plate fees may only be refunded in one year increments. Contact your county tax assessor-collector if you have any questions.

If using "old" Texas plates, the plates must be examined at your local county tax assessor-collector's office before submitting this application. To be approved, the Texas plates must be the same year as the year model of the antique vehicle, with the correct color scheme, and be in good readable condition. Qualifying license plates, such as Farm, Dealer, etc., or plates with an alpha numeric pattern that is already in use, may not be used. Replicas of Texas license plates are not acceptable. If approved, a plate tab with sticker will be issued to show valid registration.

Out-of-state vehicles that have a registration receipt only will be required to submit a completed *Application for Assigned* or *Reassigned Number*, **Form VTR-68-A**. All forms must be submitted to the county tax assessor-collector's office before the plate or tab can be issued.

Owners of vehicles that meet the limited use restriction provisions of this registration may seek an exemption from the financial responsibility requirement by contacting the Department of Public Safety (DPS) for an affidavit. If the DPS approves the exemption, a copy of the signed and dated affidavit (by a DPS agent) must be filed with the county tax assessor-collector's office when obtaining or renewing the Antique plate.

If you have not previously registered the vehicle in Texas in the last five years, you must provide proof of ownership evidence, proof of insurance (or DPS exemption), and all fees before the plate or tab can be issued.

If the vehicle is sold, junked or destroyed, you may request a refund on the unexpired portion of the plate fee at your local county tax assessor-collector's office.
