1. Does the install price of the booths need to be included in this quote- I see on the revised drawings that it states Welding booths supplied by owner, installed by contractor. However in the provisions of the quote it states include installation of the welding booths. Can you please let me know if I need to include install price?

Answer: Yes, installation needs to be included in the price. The price should include the powder-coated booths, delivery, assembly and installation. The price must be all inclusive.

2. Is there any detail information on how to connect the booths at the non-welded joints in the center of the rear wall in each booth?
