RULES AND REGULATIONS OF THE INDIAN HOSPITAL PHARMACIAST' ASSOCIATION

 Members of the Association shall be any legally qualified pharmacist practicising pharmacy in a hospital or affiliated facilities, or actively engaged in the administration, planning, or supervision of pharmaceutical practices in hospitals or affiliated facilities. Also the hospital pharmacists engaged in organization work in hospital pharmacy and those who have retired from hospital pharmacy practice, or are temporarily unemployed.

Associate members may be elected from among individuals other than hospital pharmacists who by their work in the health services, the teaching of prospective hospital pharmacist, or otherwise contributing to hospital pharmacy, make themselves

eligible for membership.

- 2. Application for membership shall be made on a form approved by the Council and submitted to the Hony. General Secretary, accompanied by the first annual subscription which shall be returned in full if the application is not entertained. No member shall be entitled to vote or be counted as a member whose subscription at the time shall have been in arrear for a period exceeding three months. Any member desesiring to retire from the Association shall send notice thereof in writing to the secretary. However, such member must have cleared his dues towards association. If any . at the time of sending a fore said notice to the Secretary.
- 3. The annual subscription shall be Rs.7/- for those members who possess undergraduate degree and RS.10/- for those members who possess Graduate degree. From new members Re.1/- will be charged as admission fee.

The members can become life member on payment of Rs. 175/-Any person contribution Rs.500/- or more to the funds of Association at a time shall be declared a patron of the Association, who shall enjoy, during his life time, the same rights as a member.

- 4. Honorary members may be elected by the Council from among individuals who are or have been especially interested in or who, have made outstanding contributions to hospital pharmacy practice. Honorary members shall not pay dues but may vote or hold office.
- 5. Associate members may attend meeting but shall have no voting powers in general meetings. They shall be eligible to serve on Branch Committees and vote therein. They shall receive the Journal and other publications, if any.
- 6. The council shall be empowered to remove from the list of members the name of :
- 1. any member whose subscription is not paid by the date of the Annual General Meeting:
- 2. any member whose conduct is considered by the Council to be prejudicial to the interest of the Association.
- 3. No member shall be entitled to vote or be counted as member whose subscription at the time shall have been in arrear for a period exceeding three months.
- 7. The Council shall have the provision for the following:

One president, one vice president, one Hony-General Secretary, one Hony. Joint

Secretary and one Treasurer. In addition, the Council will be represented by at least one member from each State and Union Territory.

8. Half of the members elected to the Council shall retire every year and the vacancies so caused shall be filled in by election.

The seats in the Council shall be distributed in such a way that at least five members of the Council (including office bearers) are the residents of the urban area in which its headquarters is located. The remaining seats shall be distributed throughout India on regional basis.

9. The Council shall prepare a report of the Association's activities every year.

Which together with the Auditors report and annual budget, shall be presented at the annual general meeting to be held in December or January.

Branches may be formed at Sate or town level anywhere in India where the members of the Association are not less than 25or 5 respectively. All the local branches situated in a particular State will be under the management of the Sate Branch. The activities of the State and local branches shall be guided by the Council of that State of town composed of one President, one Vice—president. One Hony. General Secretary, one Treasurer and adequate number of members. The members of the State of council shall hold office for two years and shall be eligible for re-election.
