**Terms and Conditions of Membership:** By signing this membership application I understand and agree that a) my membership is annual beginning September 1; b) membership is for the entire year and renews annually thereafter; c) membership dues are approved annually by the Representative Assemblies and may change from year to year; and d) if I wish to discontinue my membership (other than due to resignation or layoff) I must do so in writing to WEAC prior to the start of any membership year and, in doing so, I will also forfeit my membership in the national, regional and local affiliates and lose the rights, privileges and benefits of membership. I understand that my membership makes WEAC possible and entitles me to participate in union decisions and activities, and that as a paying member I enjoy all rights and privileges guaranteed by the union constitution.

I may request a refund of that portion of my WEAC dues payment designated for political activity by writing to the WEAC President, PO Box 8003, Madison WI 53708 between Sept 1 and Oct 30, or within 60 days of joining. This information is published annually. My membership will not be affected by a request for refund.

The NEA Fund for Children and Public Education (NEA FCPE) is a political action committee subject to regulation by the Federal Election Commission. The NEA FCPE is funded solely by voluntary member contributions, not dues, and is used primarily for making contributions to and expenditures on behalf of candidates for federal and state office. Only members of NEA and its affiliates, and their immediate family members, who are U.S. citizens or lawful permanent residents, may contribute to the NEA FCPE. Contributions to the NEA FCPE are not deductible as charitable contributions for federal income tax purposes. Law requires the union to use our best efforts to collect and report name, address, occupation and employer for each individual whose contributions aggregate is in excess of \$200 in a calendar year.
