Contractor will supply park with two 3-cubic yard containers. All containers will be picked up once per week with additional pickups as needed (\$50 per extra pick up). Containers are to be sprayed weekly with insecticide during warm weather months to control insect infestation and are to be cleaned and deodorized as needed.





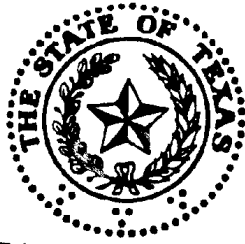

This year, rather than going through the bid process, we are asking for a quote for contract services for trash collection and disposal at Burnet County Silver Creek Park. The park is located off State Road 2341 near Silver Creek.

The contract period will be from October 1, 2011 through September 30, 2012. Two 3-cubic yard containers are required. The containers are to be picked up once per week. Burnet County may request additional pickups as needed, and the cost of extra pickups must be included in your quote. Containers are to be sprayed weekly with insecticide during warm weather months to control insect infestation and are to be cleaned and deodorized as needed. Your company must be in compliance with all Texas Department of Health Collection and Transportation requirements as set for under Municipal Solid Waste Management Regulation, subchapter C, section 324.31, page c1 and section 325.32, page c2. The monthly cost for service must be firm for the length of the contract.

In order for your quote to be considered, it must be on the enclosed response form, and we must receive it no later than August 15.
