League Requirements:

FULFILLMENT OF THE REQUIREMENTS LISTED BELOW WILL BE CONSIDERED A COMPLETE LEAGUE APPLICATION PACKAGE:

- 1. Completed League Application Form
- 2. Payment of League Application Fee
- 3. Current and completed League VIP Directory on file with Cal South Corporate Office
- 4. Current League Bylaws, Rules and Regulations on file with Cal South Corporate Office
- 5. A minimum of five (5) teams registered with the league/club. *All league/club teams and players must be registered through the CORIS System.
- 6. Active Incorporation Status with State of California (CA Secretary of State)
- 7. Active 501(c)(3) Tax Exemption Status (US Department of the Treasury)
- 8. A copy of the league's most current 2008 or 2009 IRS Form 990 or 990EZ. *New leagues may provide a Financial Forecast in lieu of Form 990 or 990EZ
- 9. Written verification of field access or field permits under new league applicant.
- 10. Any and all prior financial obligations due to Cal South must be satisfied (Applies to renewals)

*Each league bears the sole responsibility of keeping all requirements current, active and on file with the Cal South Corporate Office throughout the course of the seasonal year. Any lapse of these requirements throughout the Cal South Seasonal Year may result in a suspension and/or termination of league membership privileges.

IRS and Secretary of State Requirements

- 1. Copy of the most current league operating procedures. (Constitution, Bylaws, General Rules)
- 2. Must submit proof of current good standing with the IRS (Internal Revenue Service). In regards to your league's 501(c)(3) status is current and in good standing with the IRS.

Deadlines, Fees and Late Fees

- **Deadlines:** Youth League Application due on April 15, 2010
- **Fees:** Make checks payable to Cal South
 - 1. \$100.00 Returning League.
 - 2. \$200.00 New League (Non-Refundable)
- Late Fees: Penalties for failure to meet the deadlines
 - *A \$100.00 per month fine will be applied to all returning leagues that have not satisfied the Complete League Application Package Requirements in their entirety by April 15th.
