#### Stabling:

Stabling charges **do not** include bedding. Stabling charge includes cleaning on departure.

All stables will be padlocked at the time of your arrival. Please report to the Stable Manager for access. Stabling is available for competing horses only, from arrival on either Tuesday 7<sup>th</sup> or Wednesday 8<sup>th</sup> June 2016. Please note: we cannot guarantee stables for use as tack rooms.

Stable Bedding can be purchased during the event from WPNEC (03 9741 7672) at \$14.50 per bale. To ensure same day delivery bedding orders must be placed with WPNEC by 4.00pm each day.

order bedding from WPNEC in advance of your arrival. It will be placed in your stable and the
stable will be locked.

# Hendra Vaccination & Bio Security Policy for horses attending Melbourne International 3 Day Event:

The organising committee and Equestrian Victoria have been advised by the FEI Veterinarians that all horses entering the event from North of Forster in NSW and from Queensland, or horses that have been in these areas in the 30 days prior must be vaccinated against Hendra. Accordingly, the Organising Committee gives notice that, in submitting your entry to participate in this event, YOU WAIVE ANY RIGHT TO SEEK COMPENSATION OF ANY TYPE FROM THE ORGANISING COMMITTEE, EV OR WPNEC OR ANY OF THEIR OFFICERS, SERVANTS OR AGENTS for any loss, injury or other damage arising in any way whatsoever, directly or indirectly from the presence of the Hendra virus in any horse or person attending the event or from any person or animal contracting any illness or disability, including death, from the Hendra virus, whether directly or indirectly or howsoever otherwise.

**Off the Track** prize for Best Performed OTT horse in each CCI section – Nominations <u>must</u> be made at the time of entry on the enclosed form.

#### **EADMCP**

The new global FEI Equine Anti-Doping and Controlled Medication Program (EADMCP) has now been implemented. On 1 January 2016, the FEI announced a new global Equine Anti-Doping and Controlled Medication Program (EADMCP). The FEI's swabbing program will run concurrently to EA's anti-doping and controlled medication program. Each horse entered into an FEI event will incur the FEI's Worldwide Equine and Human Anti-Doping program fee. You will be required to pay this to the Organising Committee at the time entry.

Each horse competing in a lower level event\* will be charged CHF 18 or AUD \$26 Each horse competing in a higher level event will be charged CHF 25 or AUD \$36

### **Risk Management Conditions**

The information set out within this document *must* be included in the Prize Schedule, Competitor Information and/or Official Program for your event/s. This information must be signed by event Organiser prior to an event, and adhered to at all times.

- 1. Werribee Park National Equestrian Centre Committee of Management considers it a **privilege** that you are allowed to bring your dog to this venue. We insist you **keep your dog under effective control** at all times.
- 2. Approved Safety Helmets must be worn at all times when riding
- 3. Cross Country obstacles must not be jumped/used unless a non riding level one coach is present.
- 4. Riding of horses bareback is prohibited
- 5. Riding of rugged and/or unbridled horses is **prohibited**
- 6. Any person may lead a maximum of two horses while mounted
- 7. Stallions must at all times be in the control of a person aged seventeen years or more, when led or ridden
- 8. Horses are not permitted within/upon the quadrangle (between the barn & Indoor 1)
- 9. Horses are not permitted near pedestrian door ways
- 10. Bicycles are not permitted in the Indoor Arenas or any stable block. Approved helmets must be worn at all times.
- 11. Bicycles are not permitted near doors designated as public entrances or exits
- 12. Motor Cyclist riders must wear approved safety helmets and hold the appropriate licence
- 13. Speed limits must be adhered to at all times, the speed limit at WPNEC is 10km p/h
- 14. Power leads must not be on the ground or over roadways
- 15. Construction of portable/tape yards is prohibited
- 16. Alcohol must not be consumed in the Indoor Arenas, unless purchased from the licensed bar located in Indoor Arena No 1
- 17. Please observe all signs at the venue
- 18. Horses must be tied in a safe manner. Horses must not be tied to unattached floats, wheelie bins etc.
- 19. No infrastructure to be erected on WPNEC Grounds without written approval by management prior to event.
- 20. Entry and Exit doors to Indoors Arenas are not be obstructed at any time.
- 21. Every event to book at WPNEC must provide its own first aid officials.

These conditions apply unless the Manager or the Committee of Management has given the discipline/event/activity concerned an exemption.

\*Exemptions must be applied for in writing and will be only valid for the dates granted.\*
