## President's Message

I hope everybody had a great 4th of July, and have found a way to stay cool even with the lack of water and the triple digit temperatures. Northern California has become more of a dry arid desert as of lately. This has been a brutal month with the heat we nearly had 8 consecutive 100+ degree days this month. Folsom lake is now so low the Marina has been emptied of boats and the entire lake is under a five mile an hour speed limit. Our lakes and rivers are very low on water, and use will soon be restricted on most. So people will be turning back to their pools for use to stay cool.

On a Monday about three weeks ago, I received a phone call from a gentleman looking for some help with the local water district. He was instructed that before he attempts any work on his pool that required draining and refilling, he was to hire a pool construction company to draft a letter on his behalf in regards to why he was draining his pool, before they would allow him to continue the work. The water district is only keeping these letters on file, for reasons they won't explain. But I find it interesting that they are requiring their customers to furnish these letters before proceeding with the work. In the past three weeks I have received more phone calls from customers in the Fair Oaks Water District requesting the same letters to be furnished. These customers have been told by two of the local retail pool stores in the area that they need to drain their entire pool to fix water chemistry issues. I agree in some circumstances that some pools need to be completely drained to fix chemistry issues, especially if the chemistry can hurt the pool plaster finish, the equipment, or humans or animals. Other fixes should be tried first, before they recommend replacing all the water in a swimming pool, during such a severe drought season. Major clean ups as well as replaster remodeling will require draining. But pools with clear water and algae issues can have treatments done in most cases to rectify and prevent these problems.

I have personally found that cleaning or replacing filters or filter cartridges, installing mineral packs such as Pool RX or Frog Packs, brushing, and making sure equipment run times are running long enough, pools have done really well recovering from their issues. Even the ones with high chemical readings of conditioner, TDS, and nitrates. High Phosphates and a lack of free chlorine can both be treated and fixed without draining by using phosphate removers and non-chlorine shock (O2 shock). You need to try everything you can to avoid draining pools at this point. Customers have been told they will be fined for wasting wa-

ter or fined for over usage. I'm sure you can understand why they will call their local water company when they are told to drain their pool. Don't think for one minute that you can't also get fined for wasting water. If you send water down a storm drain you can be reported. So if you are a company that cleans your customers filter cartridges or grids curbside letting the water flow down the gutter, watch out. Some of the water districts are actually hiring water cops to drive around and ticket people wasting water. The media is asking people to report their neighbors so they can get live footage of people wasting water. It seems crazy but this will probably get worse. We have months until we may see rain and snow that will hopefully end this drought. Hopefully our state government can figure out how to manage our states water better. Do your part to conserve and work with your customers and educate them how they can save water. Fix the equipment leaks, fix the leaker pools and install pool covers or at least use the pool cover in a bottle products. Make sure autofill devices are working properly and are not continuously running. The smallest of fixes can make the biggest difference.

**Attention:** School starts for most kids in this area August 14th. Keep an eye out and drive careful in school zones, and residential neighborhoods. Children walking to and from school are even more distracted these days with cell phones, portable gaming systems, and MP3 players. We all need to be super cautious, and drive careful.

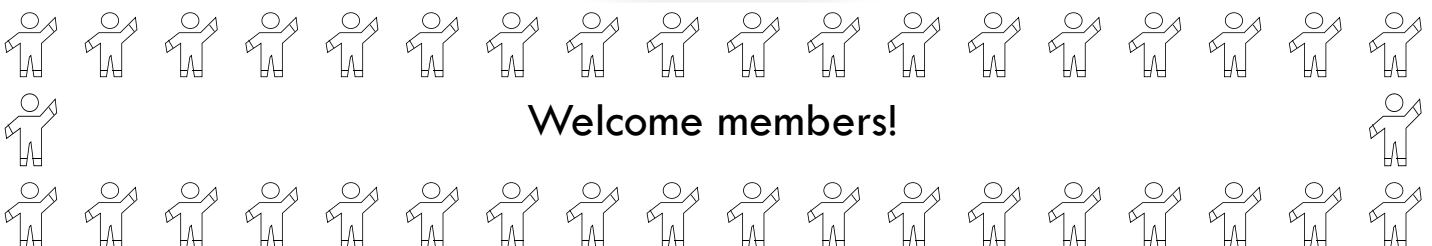
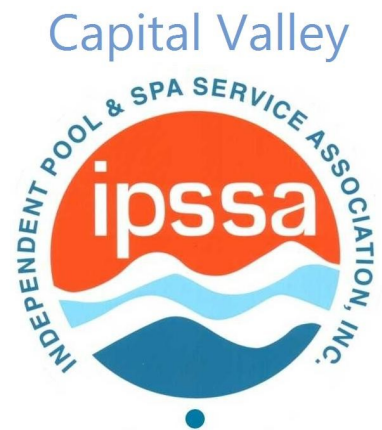
