Observership Fees: observers are required to pay an administrative fees (\$500) and additional observership fees that will vary depending on the duration of the visit and the stroke service activities that the applicant is interested in observing. The administrative fees must be submitted upon acceptance to the program. The observership fees must be submitted at least 1 week before the start of the rotation.

Required Documents:

1. Updated curriculum vitae
2. Statement of interest, specifying the objectives of the visit, fluency in English, and confirming that applicant will have sufficient funds to cover personal and professional needs during the visit.
3. Letter from the chair of your Neurology Department (if applicable) verifying that your visit to the MGH Stroke Service has been approved, that you are fluent in English, and that you are a competent neurologist or trainee in good standing in the department.

General Comments :

1. 'Observers' include physicians, trainees, medical students, nurses, industry staff, medical representatives, and other visitors who are NOT affiliated with Massachusetts General Hospital, Partners Healthcare, or Harvard Medical School.
2. While we will try our best to accommodate your requested dates and activities of interest, this may not always be possible due to the high demand for stroke service observerships.
3. Observers are welcome to attend our educational activities. These include the weekly stroke/ICU conferences on Wednesday and Thursday afternoons, Neurology Department Grand Rounds in the historic Ether Dome on Thursday mornings, Neuropathology conferences on Friday mornings, Neuroradiology rounds on Thursday afternoons, Neurovascular conferences on Friday mornings, and monthly Vascular Center rounds.
4. Observers are NOT permitted to participate in direct patient care and are required to adhere to the Hospital's policy on patient privacy and confidentiality.
5. Observers will maintain a log of all stroke service activities attended. At the end of the rotation, we will provide a letter acknowledging the duration of the visit and the clinical activities observed.
6. Appropriate U.S. entry visa is mandatory. If accepted for the observership, we will provide the necessary documents to support your visa application.
7. Housing: Short-term rentals are often difficult to find and can be expensive. Charles River Park, Beacon Hill, Back Bay, North End, and certain areas of Cambridge are within walking distance or accessible by subway. The following websites may be useful:
