

#### 3.6 Selected Target Agency Contracting Offices

The United States Army purchased more than \$41 million in fabricated structures during the last three fiscal years. The U.S. Army Corp of Engineers (USACE) is the primary contracting office for these structures. XYZ Nodular Structures Constructions Co. Inc. can market their services directly to USACE buying offices and negotiate set as side 8a contracts due to its socio economic certifications. The profile below of the USACE is provides by GovWin IQ and the U.S. Army Corp of Engineers.

#### Organization

The United States Army Corps of Engineers (USACE) was established in 1775 when the Continental Congress authorized the first Chief Engineer. In 1802 a Corps of Engineers was stationed at West Point and constituted the nation's first military academy. The United States Military Academy was under the direction of the Corps of Engineers until 1866. With the founding of West Point, the USACE began a tradition of military and civil works missions.

The USACE's mission is to provide vital public engineering services in peace and war to strengthen our Nation's security, energize the economy and reduce risks from disasters.

USACE's main function is to provide water resources management nationwide, engineering research and development, design, construction management and other engineering and real estate services worldwide for the Army and Air Force, the Defense and State departments, the Federal Emergency Management Agency, and many other international, national, state and local partners and stakeholders.

#### ORGANIZATIONAL COMPONENTS

The USACE headquarters, located in Washington, D.C., creates policy and plans the future direction of all the other USACE's organizations.

- Leadership The USACE is under the direction of the Chief of Engineers who has separate and distinct command and staff responsibilities. As a staff officer at the Pentagon, the Chief advises the Army on engineering matters and serves as the Army's topographer and the proponent for real estate and other related engineering programs. The office defines policy and guidance and plans direction for the organizations within the USACE. The USACE Headquarters is made up of an Executive Office and 17 Staff Principals. The following officers assist the Chief of Engineers in the performance of his functions:
  - Director of the Office of the Chief of Engineers
  - Commander of Headquarters U.S. Army Corps of Engineers
  - Chief of Staff
  - Engineer Inspector General
  - Principal Assistant Responsible for Contracting

The USACE Headquarters organization includes the following:

- Directorate of Military Programs: The Directorate of Military Programs provides sustainable engineering, construction and environmental management products and services for the Army, Air Force, other Department of Defense and United States Governmental Agencies and foreign countries.
- **Directorate of Civil Works:** The Directorate of Civil Works programs include water resource development activities such as flood control, navigation, recreation, and infrastructure and environmental stewardship. The mission of the Directorate of Civil Works also includes emergency response.
- The Directorate of Resource Management: The Directorate of Resource Management provides valuable budget, business practices, finance and accounting, and manpower advice to commanders, staff, and customers. The directorate develops policy and provides guidance to USACE on all aspects of resource management, including finance and accounting policy, budget formulation, justification and execution.
- **Directorate of Strategy and Integration:** The Directorate of Strategy and Integration is responsible for ensuring the USACE's strategy is in alignment with the national security strategy and the Army's strategic plan.
- Directorate of Corporate Information (Information Technology): The Directorate of Corporate Information provides the vision, policy, guidance and leadership for managing information resources and information technology within the USACE. The directorate is under the direction of the CIO, who is responsible for all aspects of information resource management, information technology, and National Security Systems (NSS) for the USACE.
- **Directorate of Human Resources:** The Directorate of Human Resources is responsible for human resource services to the USACE's management, supervisors, workforce and their families. The directorate provides the staff and operating advisory services necessary to attract and retain a qualified, motivated, efficient workforce.
- **Directorate of Research and Development:** The Directorate of Research and Development directs the USACE research and development effort for military and Civil Works programs and support-for-others by providing execution direction and oversight in the development, integration, execution, and implementation of research and development conducted by the USACE.
- **Directorate of Logistics:** The Directorate of Logistics provides direction, coordination and technical guidance through value added worldwide command logistics policy, plans, and programs for all logistics functions and business processes: supply, maintenance, readiness, materiel, transportation, travel, aviation, facility management, integrated logistics support, management controls, and strategic planning.
- Office of Safety and Occupational Health (SOH): The mission of the Office of Safety and Occupational Health (SOH) is to provide policy, programs, technical services, and oversight related to safety and occupational health matters in support of worldwide USACE missions.
- Office of the Engineer Inspector General (EIG): The Office of the Engineer Inspector General (EIG) has the mission to determine the state of discipline, efficiency, economy, morale, training and readiness throughout USACE while providing the commander a continuous objective and impartial assessment of the operational and administrative effectiveness of the command.
- Office of the Chief Counsel: The Office of Chief Counsel manages the entire USACE legal services system as a corporate enterprise by integrating legal services at the headquarters, division, district, laboratory, and center levels. The Chief Counsel Executive Office serves as

principal legal advisor and senior policy advisor to the Commander, USACE and the Chief of Engineers.

- Directorate of Contracting (CECT)
- Public Affairs (CEPA)
- Command Chaplin (CECH)
- Real Estate
- Small Business (CESB): The purpose of the Small Business Office is to develop small businesses and maximize their opportunities to participate in USACE procurements, thereby ensuring a broad base of capable suppliers to support the Corps of Engineers mission and strengthen the Nation's economic development.
- Office of Equal Employment (CEEO) Opportunity: The Office of Equal Employment (CEEO) manages and directs the Equal Employment Opportunity and Affirmative Employment Program for Commander, USACE. The CEEO also manages the EEO complaints processing system to ensure compliance with regulatory requirements and monitors the climate of USACE activities to ensure that human resource management of civilians complies with EEO/affirmative employment principles and requirements.
- Office of History: The mission of the Office of History is to collect, document, interpret, and preserve the history and heritage of the USACE. The Office of History includes research collections and a historical holding of several thousand artifacts.
- Engineering & Construction Community: Provide HQUSACE staff support; and to direct the technical aspects of engineering, construction management, environmental protection and restoration, operations, maintenance and repair activities of USACE missions worldwide.

The USACE has eight divisions, also called Regional Business Centers, throughout the United States with 41 district offices in the United States, Asia and Europe, and field offices throughout the world. The eight divisions include:

- Great Lakes & Ohio River Division (LRD): The Great Lakes and Ohio River Division (LRD) of the USACE has 5,000 civilian and military professionals serving the military and the Nation in a region that encompasses 335,000 square miles and seventeen states.
- **Mississippi Valley Division (MVD):** The Mississippi Valley Division (MVD) is a dual-mission organization with principally civil works and some military program responsibilities in the Mississippi Valley.
- North Atlantic Division (NAD): The North Atlantic Division (NAD) plans, designs and builds
  projects to support the military, protect America's water resources and maintain the environment.
  The boundaries of the NAD cover most of the Atlantic coast, including 14 states from Maine to
  Virginia and the District of Columbia (180,000 square miles, about 5% of the United States).
  NAD serves 62 million people, over 22% of the United States population.
- Northwestern Division (NWD): The Northwestern Division (NWD) has two regional offices located in Portland, Oregon, and Omaha, Nebraska, which provide direction and guidance for five subordinate districts. The NWD performs regional interface involving the upward coordination of technical policy and budgetary issues which cross district boundaries, as well as interface with many other Federal and state agencies, congressional leaders, interest groups and international commissions.

- Pacific Ocean Division (POD): The Pacific Ocean Division (POD) is headquartered in Hawaii and is charged with executing USACE missions in the Pacific area of operations that spans six time zones, from Alaska and Hawaii to American Samoa and across Polynesia and Micronesia to Japan and Korea.
- South Atlantic Division (SAD): The South Atlantic Division (SAD) has an annual workload of more than \$1 billion, and provides services to soldiers, airmen, and civilians in eight southeastern states, from Virginia to Mississippi, along with the Caribbean and Central and South America. The SAD is headquartered in Atlanta, Georgia, and has five district offices.
- South Pacific Division (SPD): The South Pacific Division (SPD) is headquartered in San Francisco, California and has three district offices in California and one district office in Albuquerque, New Mexico. Special programs within the SPD include:
  - Bay Area Housing
  - Civil Works and Management Directorate
  - Coastal Sediments Workgroup
  - Equal Employment Opportunity Office
  - Emergency Management
  - Human Resources Directorate
  - Leadership Development Program
  - Military and Technical Directorate
- Southwestern Division (SWD): The Southwestern Division (SWD) is headquartered in Dallas, Texas and has four district offices in Fort Worth, Texas; Galveston, Texas; Little Rock, Arkansas and Tulsa, Oklahoma. Overseas, the SWD supports construction and contracting work for the United States Central Command through the Transatlantic Programs Center in Winchester, Virginia.
- **Transatlantic Division:** The Transatlantic Division is comprised of The Middle East District, which provides responsive engineering, construction and related reach-back services on time, within budget, and safely to customers, partners, and stakeholders in responding to military operations, international objectives overseas, and national emergencies; the Afghanistan Engineer District-South that provides design and construction services to support the NATO International Security Assistance Force in creating the conditions that lead to improved security, governance and commerce within Afghanistan; and The Afghanistan Engineer District-North.
- **Europe Division:** Headquartered in Wiesbaden, Germany, the district provides support to various U.S., international, and host-nation customers in Europe, Africa, and parts of the Middle East.

The U.S. Army Engineer Research and Development Center (ERDC) conducts projects focused on facilities, airfields and pavements, protective structures, sustainment engineering, environmental quality, installation restoration (cleanup), compliance and conservation, regulatory functions, flood control, navigation, recreation, hydropower, topography, mapping, geospatial data, winter climatic conditions, oceanography, environmental impacts and information technology. ERDC consists of seven laboratories at four geographical sites; employs more than 2,000 engineers, scientists and support personnel; has \$1.2 billion in facilities; and conducts an annual research program exceeding \$700 million in FY02. Laboratories include:

- Coastal and Hydraulics Laboratory, Vicksburg, Mississippi
- Cold Regions Research and Engineering Laboratory, Hanover, New Hampshire
- Construction Engineering Research Laboratory, Champaign, Illinois
- Environmental Laboratory, Vicksburg, Mississippi
- Geotechnical and Structures Laboratory, Vicksburg, Mississippi
- Information Technology Laboratory, Vicksburg, Mississippi
- Topographic Engineering Center, Alexandria, Virginia

There are several field operating activities within the USACE, including:

- <u>United States Army Engineering and Support Center (CEHNC)</u> The United States Army Engineering and Support Center (CEHNC), located in Huntsville, Alabama, provides specialized engineering and technical services, program and project management, construction management, and contracting initiatives.
- <u>Transatlantic Programs Center (CETAC)</u> The Transatlantic Programs Center (CETAC), headquarters in Winchester, Virginia, is responsible for USACE operations in the Middle East, Africa, Russia and the Central Asian states of the Former Soviet Union.
- <u>Finance Center, USACE (CEFC)</u> The Finance Center, USACE (CEFC) provides day-to-day financial and accounting support to the USACE worldwide.
- <u>Humphreys Engineer Center Support Activity (CEHEC)</u> The Humphreys Engineer Center Support Activity (CEHEC), headquartered in Alexandria, Virginia, provides administrative and operational support for the USACE.
- <u>Marine Design Center (CEMDC)</u> The Marine Design Center (CEMDC), located in Philadelphia, Pennsylvania, provides total project management including planning, engineering, and shipbuilding contract management in support of USACE, Army, and national water resource projects in peacetime, and augments the military construction capacity in time of national emergency or mobilization.
- <u>Institute for Water Resources (IWR)</u> The Institute for Water Resources (IWR), located in Alexandria, Virginia, supports the Civil Works Directorate and other USACE offices by developing and applying new planning evaluation methods, polices and data in anticipation of changing water resources management conditions.
- <u>249th Engineer Battalion</u> The 249th Engineer Battalion, headquartered at Fort Belvoir, Virginia, generates and distributes prime electrical power in support of warfighting, disaster relief, stability and support operations as well as provides advice and technical assistance in all aspects of electrical power and distribution systems. It also maintains Army power generation and distribution war reserves.
- <u>Army Geospatial Center</u> The Army Geospatial Center provides a single focus point for the Army Geospatial Enterprise, focusing on all Army geospatial information and services functions from policy to warfighting.

- <u>Coastal and Hydraulics Laboratory</u> Coastal & Hydraulics Laboratory (CHL) performs ocean, estuarine, riverine, and watershed regional scale systems analyses research support work for the U.S. Army Corps of Engineers and the DoD Task Force in support of the Ocean Commission.
- <u>Cold Regions Research & Engineering Laboratory</u> The Cold Regions Research & Engineering Laboratory, solves interdisciplinary, strategically important problems of the US Army Corps of Engineers, Army, DOD, and the Nation by advancing and applying science and engineering to complex environments, materials, and processes in all seasons and climates, with unique core competencies related to the Earth's cold regions.
- <u>Construction Engineering Research Laboratory</u> The Construction Engineering Research Laboratory (CERL) is part of the U.S. Army Engineer Research and Development Center (USAERDC), which is the Army Corps of Engineers' integrated research and development (R&D) organization. CERL conducts research to support sustainable military installations.
- Engineer Research and Development Center (ERDC) The Mission of the Engineer Research and Development Center (ERDC) is to provide science, technology, and expertise in engineering and environmental sciences in support of our Armed Forces and the Nation to make the world safer and better.
- <u>Environmental Laboratory</u> The Environmental Laboratory supports the environmental missions of the U.S. Army, the Department of Defense, and the Nation through research, development, special studies, and technology transfer. Environmental Laboratory research includes a network of expertise and facilities from other Engineer Research and Development Center (ERDC) and Corps Laboratories, other government agencies, academia, and private sector.
- <u>Geotechnical and Structures Laboratory</u> The Geotechnical and Structures Laboratory (GSL) is a Department of Defense (DoD) research and engineering organization that serves the U.S. Army and the Nation by developing solutions to challenges in geotechnical and structural engineering and related disciplines.
- Information Technology Laboratory (ITL) The Information Technology Laboratory supports the research missions of U.S. Army Engineer Research and Development Center (ERDC), other Corps activities, the Army, DoD, and other agencies by conceiving, planning, managing, conducting, and coordinating research and development (R&D) in high performance computing, computer-aided and interdisciplinary engineering, computer science, information technology, and instrumentation systems.

<u>Contingency Response Unit</u> The Contingency Response Unit provides USACE Commanders with engineer battle staff capability in support of global military contingency operations. In addition, it plans and executes USACE Field Force Engineering (FFE) missions in support of combatant command operations.
