CUSTOMER CERTIFICATION

The words "I", "My" and "Me" mean each person who signs below, singularly and jointly. I certify that the above information is true, correct and complete, and that I am authorized to make this application. I understand that "FirstCaribbean International Bank" also includes any affiliated, parent or subsidiary companies of FirstCaribbean International Bank. I confirm that all statements of fact contained in this form of application are true and complete, and were made for the purpose of obtaining credit. Also that this application includes representations that I am not being sued, that no judgment is outstanding against Me and that I am not indebted to any other lender except as shown in this application.

FirstCaribbean International Bank may make application (to which I hereby expressly consent) for insurance on my life, such insurance to be owned by and payable to FirstCaribbean International Bank. It is to be effective as and from the date on which the loan is made and on such terms and conditions as may be agreed to between FirstCaribbean International Bank and the Insurer, but the amount shall not exceed the amount of the loan.
