A document that certifies the country of origin of a particular product and it is a declaration document made by the exporter.

 manufacturing license, Analysis Cost of Product, Form 24 & Form 49
- Certificate of Origin Form
- Commercial Invoice
- Supplier invoice (if any)
- Packing List
- Bill of Lading
- Custom Declaration Form (K2) & receipt
- Other related documents in respect of exports and re-exports from Malaysia (export declaration) that required by the DPMMS
