Benefits of USBOXLA Sanctioned Leagues

League Organizers/Owners/Directors

- All-in-one website for operating USBOXLA leagues including team management software, standings, stats tracking, scheduling, on-line registration, and billing and payment tracking.

- Comprehensive insurance package for coaches, referees and participants that withholds the integrity of the Box Lacrosse game.

It is critical that your league fully comply with the sanctioning procedures to ensure that there is no loss of coverage or benefits for its participants or directors. Each player, coach and referee must register and have a valid membership with USBOXLA prior to their participation in any sanctioned game or practice. There must be 100% enrollment to ensure full coverage.

USBOXLA's acceptance of this league sanctioning form indicates your agreement to follow and be bound by US Box Lacrosse Association Bylaws and the USBOXLA Rule and Situation handbook.

Any variance from the US Box Lacrosse Association Bylaws or Rule and Situational handbook must be requested and approved in writing by USBOXLA prior to their acceptance and implementation.

Complete all sections of this form. After you have submitted this agreement to USBOXLA it will be reviewed and considered for acceptance. Your league will not be considered 'sanctioned' by USBOXLA until this agreement has been approved and signed by the USBOXLA membership representative.

This league sanctioning agreement should be submitted to USBOXLA no later than 45 days before the first scheduled game or practice. Please include all necessary documents including photographs and rental agreements.

To be sanctioned, USBOXLA perspective league members must identify and describe all game and practice facilities by completing the Facility Information section of this League Sanction Agreement.

USBOXLA is involved in a sport that is practiced by men and women and girls and boys of all ages in the United States. It is the position of USBOXLA that no member should be exposed to any unnecessary risk to his or her health and safety, including but not limited to, sexual, physical, emotional or ethical abuse or neglect. Minors participating in sports programs may be targeted by predators and are at increased risk for these and other types of abuse. For Sanctioning, ALL Leagues must abide by and acknowledge and implement the sexual abuse policy, the physical abuse policy and the screening policy of USBOXLA.

A sanctioned USBOXLA league must adhere to the rules set forth in the USBOXLA Rules and Situational Handbook publication to establish consistency and uniform game-play within the sport of Box Lacrosse in the USA, regardless of where it is played.
