Special General body Meeting

Date held: 12th April 2009

Minutes of the meeting are as follows:

- 1. The meeting began with Prayers by Shastriji, Panditji and Kiranji.**
- 2. Invocation of Program by Shastriji, who extolled on the virtues of Building the new temple, benefits to devotees and the community**
- 3. Presentation of slide show describing Bhoomi Pooja**
- 4. Welcome to all members and devotees by Chairman Manoj Sachdeva**

All Board members were present.

Questions and Answers

Manoj Sachdeva began the meeting by describing the huge amount of work done by the Board and volunteers in planning the expansion of the temple.

Umesh Rohatgi, said that in any meeting the previous minutes should be Read and accepted. Manoj Sachdeva responded that the previous minutes of the Annual General Body Meeting were published in "Vandana". However a motion was made to accept the previous minutes. Motion passes, no questions.

Manoj Sachdeva quoted Sri Sri Ravi Shankar on "Relief from Anxiety" as follows:

Today many are anxious about how to deal with anxiety! Here are some of the ways you can manage it.

- 1. Sing, dance and celebrate. The very intention to celebrate will pull you to a more harmonious state.**
- 2. Think about what you can do for others rather than about yourself. Get energized with service activities.**
- 3. Practice yoga, breathing and meditation.**
- 4. Know the impermanence of the world.**
- 5. Have faith in and surrender to the Divine. Know that there is a supreme power that loves you, is behind you and accepts you totally. Feeling secure comes with the sense of belongingness.**
- 6. Be courageous and invoke the lion within you.**
- 7. Have an attitude of sacrifice.**
- 8. Remind yourself that you are committed to a greater goal.**
- 9. Be unpredictable for a while. Anxiety is always related to some anticipated action so do something completely irrelevant and unpredictable.**
- 10. Be ready to face the worst. This will leave you with stability in the mind.**
- 11. Remember a similar situation in the past when you were able to overcome your anxiety**

He also said that everyone was updated in quite detail about the temple expansion, both at the Annual Fund Raising meeting last November and at the Annual General Body Meeting in December 2008.

Since then, our Construction Management Team headed by Rand Construction assisted by Architects from Lindhout & Associates, have worked very diligently to complete 100% of the drawings, bid the entire project very competitively.

Initial cost was projected as \$8,400,000 which came down to \$7,880,335.

Avinash Rachmale was thanked for reviewing items, checking them and getting bids to keep the costs low. He also received various quotes, competitive bids From reputable contractors.

Andy Klein from Rand Construction, explained the process of working closely with neighboring communities, overcoming obstacles and making sure that the new temple is unique, beautiful, and economical and a sustaining project.

Jignesh Patel, from Lakeshore Engineering explained the process of estimation To create and build the best temple.

Financial Updates:

Anil Sakhuja, explained the budget that was presented to the General body. He went over the, receivables, expense projection for construction activities and Day to Day operating expenses.

The Board of Trustees and General Body had decided in previous general body meeting to restrict \$500,000 as contingency funds. The decision stands to continue with official reserve of \$ 500,000. Further, Anil Sakhuja went over the budget on a line by line basis.

Manoj Sachdeva said that Andy Klein from Rand Construction has put together a construction schedule on display at the General Body Meeting to start construction on May 25, 2009, completion by March 2010 and move to new Temple in June 2010

He also announced that the materials to be used are on display in the temple hall and everyone is encouraged to review these materials. All of these will be part of the temple construction.

A thousand bricks that will be used in construction have been delivered. These bricks will be offered by devotees with special prayers and blessings from our very own Shastri Ji and other Priests on Ground Breaking Day. All permits have been obtained and we are ready to break ground. He also said that all Life members will take part in the actual ground breaking ceremonies during Bhoomi Pooja.

Question and Answer session.

1. From Mr.Brij Seth.

He thanked the board for presentation of the budget

Q. He said that the temple debt will be 5.4mm at the end of 2012.

What is the board's strategy for getting rid of this debt?

A. Anil Sakhuja replied that temple will have 1.7MM in hand and just in case temple is not able to meet its obligations, a commitment has been obtained from board for 1.5MM. The temple hopes to receive additional funds in the next 3 years to repay all debt.

Manoj Sachdeva added that this project is to build a future for the children.

Few people have paid ahead of time. The Board has conference calls every Wednesday and the board meets every Saturday for Fund Raising Strategy.

We are building class rooms, once we have those class rooms, we can initiate a Charter School, but we are not projecting any income from this at the present time

There will be a new banquet hall that will be available for rent. Bal Vihar Activities will grow.

2. Mr. V.B. Bajaj

Congratulations to the board, efforts are well recognized. He said that He could assist the temple in getting things like "OM" artifacts.

3. Mr. Umesh Rohatgi.

Q. Instead of keeping \$500,000 as contingency funds in the bank, why not spend it?

A. We will evaluate the situation and we will try to repay the loan by Contributions from devotees

4. Mr. Tom Patel.

Praised the board for a job well done. Board is very optimistic about collection of funds.

Q.Total commitment is 10.8MM. The mortgage payment and interest will amount to \$1MM/year.

A. Anil Sakhuja said that this is not correct; we will have 5.4 million due in 2012.

Tom: We still have to go for collections. If we hope to pay off 40% of the loan in 3 years that will be good. Planning started 4 years ago and we have supported the board.

Anil: We have people who are committed and will donate, so projections will be met. On Bhoomi Pooja day we will announce our collections and balance.

Q. If the projection of collection does not come about, then what?

Pledges are never fully recovered; the budget shows only figures for last 2 years. Realistically, projections should be for 4 years in the real world

A. Anil Sakhuja. Pledges will come. Plan is pledges are distributed over 10 years. The two years projection is due to current Michigan economy. So even if we do not get the Pledges, new money from new pledges is coming in. We did not show high operating revenues because of the bad Economy. We are hopeful that everything however will come back. We are all hopeful that donations to the temple will increase. The goal is to have a commitment to pay off the Mortgage in few years.

5. Satish Mistry.

Q. What board has done is commendable, we are limited by size and cannot do much. We still have a parking problem. We have 300 spaces but 2,000 people may attend functions. Demolition of this hall is a waste of 3MM dollars.

A. Suresh Shah:

Satish Mistry has given his input to me on several occasions. He has the right concern. We had a 15 member long range planning committee. 500 signatures were collected for not moving the temple and also not to sell the property, so General Body decided not to move. We spent 18 months to see how we can expand the current building. The cost was almost 4.4MM dollars as there were a lot of structural problems. The Altar area has a lot of problems, leaks etc. Because of all these problems we decided against spending 4.4MM to expand the current structure.

6. Q, Parking is always a problem. Major events need shuttle service.

Why can't we use neighboring church lots and solve the problem, 90% of the time Parking will suffice.

A. Nitin Desai: We have requested neighboring churches, but because of their Sunday services, they cannot accommodate us. Meijers will not allow us because of liability issues. There is no response from Farmer Jack. We don't want to park where we are not allowed. Bhoomi Pooja parking is in Plymouth-Canton Park site. The Aarti will be staggered so as to alleviate Parking.

Manoj: Traffic plan was presented to the township, we were given the go ahead. We had to satisfy neighbors. All questions were answered. We want to be a solution and not part of a problem

7. Meera Desai:

Q. Will the board commit to a community center for children and families in?

The new temple?

Will children have to pay?

A. Bela Patel:

Lots of kids have structured activities-Bal Vihar. We should have lot more activities for children who have the energy. College level activities. We want to have Adult participation to encourage children. Have a special committee for these activities as children are the future generation. This is the plan for the new temple. We want children to learn more about our religion and heritage. Shastriji, all should participate, have summer camps etc.

Manoj: We need help from Children. Be a Champion, be a mentor.

We need help from Mothers too, to guide the children. "Mothers can make anything happen"

8. Suresh Shah:

Q. What is the vision of the temple, 10 years from now? Provide input to Board.

A. Manoj: We need more people to engage in all temple activities

9. Mr., Bhagu Patel:

Q. There are long lines for turning left as you exit the temple, what are The improvements?

A. Wayne Count has made suggestions. We will have an entry lane and an Exit lane, when we have traffic plans developed.

10. Satish Mistry: Temple belongs to community, temple will always survive

Bela Patel: Temple will survive with younger generation

Suresh Shah thanked all the founders of the temple.

Manoj Sachdeva thanked everybody for attending the meeting and said we hope that everybody is now well informed. He continued to say that we look forward to all of you joining all of us in celebrating Bhoomi Poojan in grand style with 3 days of celebrations on May 15, 16 and 17th and thanked everyone for their generous support in helping to build a beautiful looking temple for Bhagwan Ji. He chanted "Tere pujan ko Bhawan Banaigae Mandir Alishan, Banaigae Mandir Alishan, Banaigae Mandir Alishan"
