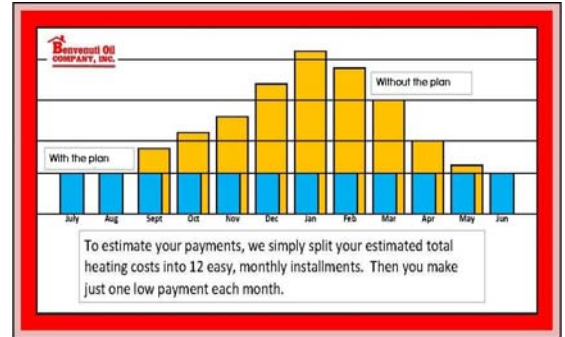

Benvenuti Oil's Terms & Conditions: Automatic Payment Plan: Your full budget payment (Total Due This Month) will be billed to the method you've chosen on the last business day of each month after the initial payment. Capped Smart Pay Budget Plans: Your 1<sup>st</sup> budget payment is the cost to enroll / secure your price cap protected gallons and is non-refundable. Your account will be billed the lesser of the cap price or the ticket price less discounts, if any. Incorrect Gallons Used To Figure Monthly Payment: The homeowner is ultimately responsible for the oil consumed in their home and if the gallons used exceeds the budgeted amount the cap will not apply to the overage gallons and the customer may owe an additional amount. If the customer misses 2 budget payments or if their balance becomes greater than 2 budget payments the customer will be required to pay an increased amount prior to the next service or delivery. Un-capped Plans will be billed at the ticketed price less any discounts, if any. At the conclusion of your budget: The customer agrees to pay any outstanding balances. Past Due Accounts: Failure to maintain your account in good standing will result in early termination from the budget plan. The customer agrees to pay late fees, finance charges, collection fees and interest on unpaid balances. Customer agrees to pay \$35 for any returned payments or checks. Early Termination/Liquidation Fee: If you terminate your budget plan in less than 12 months, you agree to pay an early termination / liquidation fee of \$99. Home Sales, Assignment, Refund Requests: The customer may request a refund at the completion of their budget in writing to Benvenuti Oil. There is a \$50 liquidation administration fee deducted from the refund. Automatic Oil Delivery: We require all our budget customers to be on automatic oil delivery & the customer agrees to receive all their oil from Benvenuti Oil. Upon the completion of the oil contract we will continue to deliver your oil automatically to ensure you don't run out which could cause home damage. Will Call Oil & Minimum Delivery: If a customer requests to call for each delivery (will call) there is a 150 gallon minimum delivery & if a customer fails to receive at least 100 gallons a \$50 delivery charge will be added. Force Majeure: Duty to Perform: Benvenuti Oil Company, Inc or related parties will not be liable for any breach, delay or nonperformance hereunder which results from, in whole or in part, civil commotion, labor unrest, strike, war, fire, storms, supply disruptions, embargoes, or other restrictions imposed by law, floods, other acts of God, or other impairment with the seller's supplier(s). These terms and conditions will continue for 60 months from signing. If an automatic delivery customer wants to make a change to their account please notify us by certified mail, email or fax. Businesses and Non-Residential Customers: If the oil is used primarily for non-residential heating you are required to pay 6.35% State of Connecticut sales tax on your oil.
