REPORTS AND DISCUSSION ITEMS

Transition Class at Windham High School (Ref. 9)

Mr. Blain explained that due to funding from a grant written by Mr. Stover and Ms. Ledey, there will be a new position at the high school which will address the needs of students transitioning back into the classroom due to various reasons. The teacher in this position will assist students with classroom and attendance issues working to help students meet with more success in school. Mr. Blain answered questions and Mr. Folan thanked him.

Meeting with Commissioner of Education (Ref. 10)

Mr. Folan provided an overview of the recent meeting that Mr. Perzanoski and he had with the Commissioner of Education and the Commissioner's cabinet. Windham has many good initiatives already in place; however, there will be financial burdens placed on the district. When the Commissioner asked what he could do for Windham, Mr. Folan replied that he should start lobbying the legislature so that funding goes directly to the district, not to the town, and he asked the Commissioner to attend a public forum in Windham to speak to community members, town leaders, parents and teachers and answer their questions so that everyone understands what is being asked of the district and the financial implications that are involved. Mr. Folan has been in touch with the Commissioner's office and hopes to have a date for the forum by this Friday.

Mr. Perzanoski said that the Commissioner asked many questions about the district. At tonight's meeting, Mr. Perzanoski distributed information from the State Department of Education's Bureau of Accountability, Compliance and Monitoring, along with a listing of the Next Steps with a timeline.

Both Mr. Clements and Mr. Doyle questioned the aggressive timeline. There was discussion about the timeline and the fact that this initiative has been presented after the district's budget has been put in place. It was questioned why the district would be responsible to pay for the state required audits. Mr. Folan agreed that the timeline was aggressive but didn't think that it was set in stone. Mr. Folan felt that it would be important to follow up with a budget forum once the forum with the Commissioner has taken place. Board members had many questions about the requirements indicated by this new legislation. Mr. Folan said that it is important that the Commissioner visit Windham to explain in detail the impact and ramifications that this initiative will have and to answer questions.

Financial Statement July 2007 (Ref. 11)

Mr. Nelson pointed out that some line items show deficit numbers because savings are anticipated as a result of some of the summer projects.
