# Windham High School Music Program (Ref. 7)

Dr. Summa explained that there has been discussion regarding the marching band at the Program Development and Evaluation Committee level and she asked Mr. Blain and Ms. Savoie to update the full Board. Mr. Blain reported that an indepth assessment looking towards the future of the high school music program was conducted. Ms. Savoie explained that she had done research on the marching band at Windham High School from 1958 to the present time. She also met with the band officers to generate a list of their goals for the marching band, as well as with the entire band to generate a second list. Ms. Savoie explained that the process would take more than a year. She, Mr. Blain, and assistant marching band director, Tom Franklin, answered questions from Board members. There was some discussion. Mr. Folan indicated that communication is important and said there will be a meeting between the high school and the middle school some time before September. He said that the Board appreciates all of their efforts and enthusiasm and thanked them for their time.
