MEMBERSHIP AGREEMENT - TERMS & CONDITIONS

The Clubs shall have the absolute right to designate, from time to time, persons who are eligible for membership and who shall have the right to use any and all of the facilities of the Clubs, upon such terms and conditions as determined from time to time by the Clubs. Eligibility for membership shall not be based on ground of sex, color or national origin.

- A. This application is for membership in and thereby to enjoy the Club privileges of American Tactical Training Arms Center LLC and Ancient City Shooting Range in St. Augustine, Florida (hereinafter collectively referred to as "the Clubs"). This application will not be acted upon unless fully completed, executed and accompanied by a credit card, EFT (electronic fund transfer) or check for payment of the required annual dues and initiation fee.
- B. The Applicant recognizes, acknowledges, and expressly assumes any and all risks associated with his/her presence and/or the presence of his/her family or guests on the Clubs' property or facilities, including, but not limited to, the shooting ranges, simulation houses, clubhouse, pro shop, dining areas, parking lots and any and all risks associated with the rental or any other use of the Clubs' property, including, but not limited to, appliances, electric carts and firearms. The Applicant expressly acknowledges that participation in sports, firearm/tactical training and/or recreational activities or presence on property intended for sports, firearm/ tactical training and/or recreational activities may subject the Applicant and/or his/her family or guests to hazardous and/or dangerous conditions such as damages, injuries or losses that the Applicant and/or his/her family or guests may incur as a result of, among other things, lightning or other weather conditions, being struck by any foreign objects (including ammunition (of any kind), firearms, target systems, sports equipment and the like) and the negligent operation of firearms. The Applicant hereby assumes the risk of personal injury and the loss of and/or damage to personal property and releases and agrees to release, waive, indemnify and hold harmless American Tactical Training Arms Center LLC, Ancient City Shooting Range and their respective parents, subsidiaries, affiliates, related corporations, agents, officer, directors and employees, from and against any and all losses, cost and/or liabilities for claims, demands, suits or causes of action in law or in equity for damages and injury, including death, of every kind and nature, whether to persons or property, arising out of or in any manner related to (i) the Applicant's (or his/her family's or guests,) presence at the facility and/or participation in sports, firearm/tactical training and/or recreational activities at the facility, (ii) the Applicant's (or his/her family's or guests') rental or use of Ancient City Shooting Range's property, (iii) the Applicant's (or his/her family's or guests') use of the facility, services, including but not limited to, firearm repair, firearm instruction, and/or (iv) the presence of the Applicant's (or his/her family's or quests') personal property at the facility, regardless of negligence, act or omission of any director, officer, employee, representative, affiliate or agent of the Clubs or arising out of or incident to membership in the Clubs and/or use of the Club's facilities provided the Applicant shall not be responsible for damages and injury caused by the negligent or wrongful act of the facility.
- C. The Applicant further agrees to be responsible for all damage and/or injury (including death) to, or loss of property of, the facility, the facility's members or guests, caused by the Applicant, the Applicant's family or guest, and/or the presence of the Applicant's (or his/her family's or guests') personal property at the facility. Personal property of the Applicant, his/her family or guests, present at the facility shall be so at the owner's risk; the Clubs will not be responsible for lost, damaged or stolen property.
- D. I have inspected all documents and obtained all information that I believe necessary to further my decision to execute this Membership Application and Agreement and I acknowledge that I have the right to consult with an attorney if I believe such advice to be necessary. I agree to be bound by all the terms and conditions of the Rules and Regulations, other documents referred to therein (as amended from time to time), and any and all other rules and regulations established by management from time to time. Membership is subject to suspension or treatment for failure to abide by membership conditions. Applicant further acknowledges and agrees to be responsible for all charges incurred that shall be due and payable no later than ten (10) days from the date of the monthly statement. All costs and expenses incurred by the Clubs in the collection of any amounts not paid when due, including, but not limited to court cost and attorney's fees, whether at the trial level or an appeal, shall be charged to applicant, and shall be due and payable upon demand.
- E. Applicant hereby acknowledges that he/she is acquiring a membership for the sole purpose of obtaining recreational and/or social use of the Clubs facilities, and not inter alia, as an investment, for any economic profit, or for the purpose of obtaining any equity or other ownership interest in American Tactical Training Arms Center LLC and/or Ancient City Shooting Range. Applicant acknowledges that except under certain special membership categories, memberships are non-transferable and that the initiation fee as may be paid hereunder is nonrefundable.
- F. Applicant acknowledges that membership is a revocable license subject to permitted renewal and termination at the sole and absolute discretion of the Clubs. Membership is not an investment in the Club, nor does it provide an equity ownership interest in the Clubs or the Club's facilities. The Clubs reserve the right, in its sole and absolute discretion, to terminate memberships in the Clubs, to discontinue operation of the Club's facilities, to sell or otherwise dispose of the Club's facilities in any manner whatsoever and to any person whomsoever and make any changes in the privileges and conditions of the membership or the facilities available for use by members. If the Clubs elect to terminate all Club memberships, applicant shall be entitled to a pro-rated refund of the annual dues not yet accrued for such memberships based upon a monthly schedule, but in no event shall applicant be entitled to a refund of all or any portion of the initiation fee.
- G. Applicant acknowledges that use of the Club's facilities may be restricted or closed from time to time (at owner's sole discretion) for construction, training or competition events. ATTAC reserves the right to change the hours of operation or close due to inclement weather. Changes will be posted on the website. Applicant is responsible for confirming dates and times of operation.

I/We accept the invitation to join Ancient City Shooting Range and agree to be governed by the Conditions of Membership as
may be amended from time to time at the sole discretion of Club Management and Owners. I/We have been furnished a copy of
the Club's Conditions of Membership and by my signature below further understand that I assume all liabilities for dues and
charges incurred by me, my family and quests. Membership in the Club does not confer upon a Member a vested right or an
easement to use the Club's facilities. A Member only acquires a revocable license to use the Club's facilities.
