

Data from both inside and outside Pennsylvania reflect that, while women are hired and compensated at levels commensurate with men at the inception of their legal careers, they tend to leave the profession or move to lower-paying positions after about 4-5 years in practice — at about the time they begin a family. The data also indicate that a powerful driver of this phenomenon is a perceived inability to balance the competing demands of firm and family.


