PROFESSIONAL EXHIBITION (PRO) RATING PROFICIENCY CARD

Qualifying Demonstration Performance Jumps

USPA PRO Exhibition Ratings are issued to members who have, using the same model and size canopy, accomplished a series of ten consecutive (as declared) jumps into a ten-meter (32-foot) diameter target area. Each landing must be made standing up, and the jumper must make the first contact and stop within the ten-meter circle. All qualification jumps must be made in the presence of an S&TA, I/E or member of the USPA Board. Except for the minimum 500 ram-air jump requirement, all training listed on this card must be made within the previous 12 months of this application.
