Agreement to Participate-Assumption of Risk and Release

Whereas, the undersigned (the "Applicant") wishes to be accepted for participation in Paintball &/or Challenge Course Experiences&/or Power Pole &/or Obstacle Course &/or Target Shooting &/or Water Slip-N-Slide conducted by King's Domain Camp; and in consideration of King's Domain Camp action in allowing the Applicant to participate in such a program:

The undersigned acknowledges that during the said activities that the Applicant is requested to participate in, that certain risks and dangers may occur: These include, but are not limited to, the hazards of playing paintball, depending upon other people, being at various heights (ground level up to 50') accident or illness in remote places without medical facilities, and the forces of nature.

The undersigned further recognizes risks may also include loss or damage to personal property, physical or psychological damage and/or injury not excluding fatality due to accidents which may occur; including accidents resulting from this paintball and challenge course experience or other type of outdoor activities. I further understand that in participating in the activities I am requesting to participate in, I may be exposed to the elements of nature, including temperature extremes, and inclement weather. I further understand that medical treatment may be several hours away in the event of a medical emergency.

In consideration of and part payment for the right to participate in such a program and the services and food arranged for me by King's Domain Camp, it's shareholders,, Directors, Officers,

Employees, Agents, and/or Associates, I have and do hereby assume all the above risks and any other ordinary risks incidental to the nature of the program, including risks which are not specifically foreseeable, and will hold them harmless from and all liability, actions, causes of actions, debts, claims and demands of every kind and nature whatsoever, whether from bodily injury, property damage or loss or otherwise, which I now have or which may arise from or in connection with my program or participation in any other activities arranged for me by King's Domain Camp, it's Shareholders, Directors, Officers, Employees, Agents and or Associates, in their heirs, executors, and administrators.

The terms hereof and my signature on the document shall serve as a release and assumption of risk, and shall bind my heirs, representatives, executors, and administrators, successors, and assigns and for all members of my family, including any minors accompanying me. I also state that I am not under, and will not be under the influence nor will I be under the influence of any chemical substance including alcohol. I fully understand that any physical activity involves risk of injury. I also understand that my participation in the King's Domain Camp program is entirely VOLUNTARY and that I may excuse myself from participation if I so desire.
