TERMS & CONDITIONS***PAYMENT TERMS**

To secure your corporate package for Season 2014, a signed order form is required. Please refer to page one (1) of this document titled 2014 Corporate Partnership Agreement ("the Agreement"). Within seven (7) days of signing the Agreement, a ten (10) percent deposit (calculated on the full price of the Agreement) is payable. The balance of the Agreement (ninety (90) percent (%)) is payable in two (2) equal part payments of forty five (45) percent (%) (of the original balance). The two (2) equal payments are payable as follows; the first within thirty (30) days of the deposit being paid and the remaining forty five (45) percent (%) payable prior to (or on) the 28th of February 2014.

A corporate package is not guaranteed until one hundred (100) percent of the Agreement is paid in full. For payments not received by the 28th of March 2014, the Port Adelaide Football Club reserves the right to withhold (or void) any remaining benefits. This decision will be at the discretion of Senior Executives.

Amendments to the payment conditions of this contract are not deemed valid until the amendment is documented on official Port Adelaide Football Club stationery, signed by both parties and referred to as an annexure to this Agreement.

EVENTS

In the event that you are unable to attend a Port Adelaide Football Club Event (including Season Launch, Gala Auction and Best & Fairest), tickets may be transferred to family members, friends or colleagues. Ticketing can not be transferred to another event. Refunds will not be provided if you can not attend the event.

ACCEPTANCE OF AGREEMENT

I hereby certify that I have carefully read and agree to adhere to all of the terms and conditions on the front, back and any covenants attached to this agreement form. At the time of signing this order, all material particulars are duly completed and this order comprises the entire agreement in relation to goods and services. I am aware that until this agreement is signed on behalf of the club, by an authorised person, this agreement does not constitute a legally binding contract. I confirm that I am of 18 years of age or older and understand the terms of this agreement. I acknowledge that I am in receipt of a copy of this agreement.

CAR PARKING

Season car parking passes are non-transferable and cannot be used during home AFL finals.

LOST OR STOLEN TICKETS

You acknowledge that the Port Adelaide Football Club is under no obligation to replace any ticket, credential or pass which has been misplaced, lost or stolen. It is at the sole discretion of the Port Adelaide Football Club to issue replacement ticketing; fees and charges may apply.

PRIVACY ACT

The Port Adelaide Football Club has taken the necessary action to ensure all personal data is stored in accordance with The Privacy Act 1988. As a part of the marketing of the Club, you may from time to time receive information from sponsors or associated organisations. The distribution of any sponsor or third party material is at all times controlled by the Port Adelaide Football Club and as such at no time is the contact information of any member provided to any third parties. By applying to become a corporate partner, you are consenting to the Port Adelaide Football Club acting in this manner.

PART PAYMENT CLAUSE

In the case of two (2) part payments, one (1) tax invoice will be issued. The payable amount will be scheduled by the due date at the bottom of the invoice. Each payment schedule will be characterised by the primary invoice number then hyphenated by payment schedule. ie (100 (primary invoice) -1 (payment schedule) 100-1 and 100-2).
