#### **RULES & REGULATIONS**

- 1. All exhibitors are required to complete the enclosed contract form for exhibit space. The contract must be returned with full payment of preferred booth amount. If booth requested is not available, then a refund for the difference will be given. Homespun, Box 446, Carlyle, SK S0C 0R0 no later than February 28, 2015.
- 2. All applications will be reviewed and juried by the Homespun Committee. Booths will be allocated by the Homespun Committee. TWO PHOTOS MUST ACCOMPANY APPLICATION FORM. Photos will not be returned.
- 3. No refunds will be given to exhibitors cancelling from the show after September 1, 2014.
- 4. Exhibit space shall not be sublet, traded or sold without the approval of the show committee.
- 5. Display booths will include: 8' high back drape
  - 4' high side drape
  - 1 6' or 8' skirted table (extra tables required will be an additional
    - cost of \$15)
  - 2 folding chairs
  - 1 600 watt duplex electrical outlet

Please note that the use of excessive lighting beyond the capacity of the 600 watt outlet included with the booth package creates problems with the boothing company's electrical system.

Please use LED lighting if possible, or restrict the number of lights in your display.

- 6. Security will be provided overnight Friday and Saturday.
- 7. Displays may not be dismantled prior to 4.05 p.m. on Sunday, September 21, 2015.
- 8. Exhibitors must contain their products within the boundaries of their exhibit space.
- 9. The show committee reserves the right to terminate any activity or remove any product which in their opinion is objectionable or inappropriate or is detrimental to the quality of the show.
- 10. There is no smoking in the Carlyle Sports Arena.
- 11. The exhibitor must maintain qualified personnel in their display during all hours of the show. Note: Hostesses will be available to assist you should you need to take a break.
- 12. The exhibitor is responsible for obtaining any insurance related to his/her participation and requirements or his/her exhibits in the show. Neither the show committee, nor their officers, nor agents will be held responsible or liable for any manner of loss or damage that may occur to property or persons during times of move in, show, and/or move out.
- 13. The exhibitor will be responsible to supply sufficient product for two-day sales covering approximately 4000 Patrons.
