- 3. Firms/ Contractors who have been black listed by any Govt./ Semi Govt.,/ Board/Corporation/ Pvt.Organization shall not be considered. An Undertaking to this effect shall be given by the agency.
- 4. CITCO, reserves the right to verify the particulars furnished by the applicant Independently. Any information furnished by the applicant if found incorrect at a later stage, the firm/ contractor shall be liable to be debarred from future tendering in CITCO.
- 5. All dispute concerning in any way with this work are subject to Chandigarh jurisdiction only
- 6. Conditional tenders, tender without Earnest Money and tender on the non prescribed form, tender by post / telegram shall not be entertained.
- 7. Agreement shall be drawn with the successful tenderer on prescribed CPWD Form No.8 as per "General conditions of the contract of CPWD works-2008" (which is available as a Govt. of India Publication) and the Amendment/changes in clauses of the General Conditions of the contract for CPWD works-2008. Tenderer shall quote his rates as per various terms and conditions of the said form, which will form part of the agreement.
- 8. The time allowed for carrying out the work will be as mentioned above from the date of start as defined in Schedule 'F' or from the first day of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
- 9. The site for the work is available.
- 10. Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools and plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Corporation and local condition and other factors having a bearing on the execution of the work.
- 11. The Chandigarh Industrial & Tourism Development Corporation Limited does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without the assignment of any reason. All tenders, in which any of the prescribed conditions are not fulfilled or any condition including that of conditional rebate is put forth by the tenderer, shall be summarily rejected.
- 12. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 13. The Chandigarh Industrial & Tourism Development Corporation Limited reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.

- 14. The contractor shall not be permitted to tender for works in the CITCO (responsible for award and execution of contracts) if his near relative is posted in any capacity. He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any officer/official in the Engineering Department U.T. Chandigarh. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department as well as for future works.
- No employee of CITCO is allowed to work as a contractor for a period of two years after his retirement from service, without the previous permission of the Corporation in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Corporation. As aforesaid before submission of the tender or engagement in the contractor's services.
- The tender for the works shall remain open for acceptance for a period of NINETY (90) DAYS from the date of opening of tender. If any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the CITCO shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said Earnest Money as aforesaid and to forfeit the whole of the Earnest Money if the tenderer fails to submit the Performance Guarantee in the prescribed time after issue of letter of acceptance.
