Agreement Between the County of Yolo and the City of Woodland Regarding the Transfer of a Portion of County Road 102

This Agreement ("Agreement") is entered into this _____ day of ______, 2015 by and between the County of Yolo ("County"), a political subdivision of the State of California, and the City of Woodland ("City"), a California municipal corporation.

WITNESSETH

WHEREAS, certain roads located within the unincorporated areas of the County are bordered by roads within the incorporated areas of the City in a manner which makes ongoing maintenance, repair, and traffic control of the roads cumbersome; and

WHEREAS, Government Code Section 25365 permits the County Board of Supervisors, by a four-fifths vote, to convey to the City any real property belonging to the County, upon such terms and conditions as are agreed upon if the property to be conveyed is not required for county use; and

WHEREAS, Government Code Section 25365 requires that the County publish a notice of its intended action at least one week prior thereto in a newspaper of general circulation published in Yolo County; and

WHEREAS, the County Board of Supervisors has determined that the property that is the subject of the transfer to the City pursuant to this Agreement is not required for County use; and

WHEREAS, Government Code Section 37351 permits the City to receive such real property situated inside or outside the city limits as is necessary or proper for municipal purposes; and

WHEREAS, the City Council has determined it is necessary and proper for municipal purposes that the City acquire the property that is the subject of this Agreement, and adopted City Resolution No. 6363 to this effect;

NOW THEREFORE, the County and the City agree as follows:

- 1. County shall quitclaim to City the County's portion of the following roadway segment, including right-of-way and improvements, from one edge of the right of way to the other, and transfer the corresponding maintenance responsibilities:
 - That portion of County Road 102 between the existing city limits at the easterly projection of County Road 25A, and a point approximately 1,000 feet south of the southern city limits, described in Exhibits A and B attached hereto.
- 2. The area described in Paragraph 1 shall be included in the City's storm water control plans.
- 3. The City shall accept the roadway segment, including right-of-way and improvements described above, and shall cause the quitclaim deeds and certificates of acceptance to be recorded in the office of the County Recorder.
- 4. The parties agree that no consideration, other than the mutual promises and benefits that are contained herein, are contemplated by this Agreement, and that neither the County nor the City will be required to compensate the other or its officers for any services performed under this Agreement.
- 5. Copies of this Agreement shall be provided to all affected police and fire service agencies. The parties hereto agree to execute any additional documents necessary to secure public protection services provided by agencies other than the City or County.
- 6. This Agreement shall become effective when approved by the Board of Supervisors and the City Council.
