Horse Trials PEI is very happy to announce that Ian Roberts of Dreamcrest Farm, Ontario, will be coming to PEI to teach a two day Jumping and Cross-country Clinic. This clinic will be held at the Strathgartney Equine Park in Bonshaw, PEI on July 27th & 28th, 2013.

Ian Roberts owns and operates Dreamcrest Farm in Port Perry, Ontario. He has ridden in the Olympics, World Equestrian Games and PanAm Games and has coached Young Rider teams. In 1989, Ian was voted Ontario Horse Trials Association's Coach of the Year, and in 1995, was both the Ontario Equestrian Federation's Male Rider and Coach of the Year.

Ian is just one part of a very successful eventing family. His wife, Kelly, rode in the Olympics and his son, Waylon, competed in the Pan Ams in Brazil.

This will be a two day clinic, with a focus on Show Jumping on Saturday and Cross-Country on Sunday. Preference will be giving to two day riders, but if space permits, one day entries will also be accepted. Lessons will be 1-1/2 to 2 hours each, (max 4 riders per lesson) depending on final number of entries received.

Entry Deadline: July 15th, 2013. Spots will not be held without fully paid entries in hand. Your entry must be in hand, paid in full, before deadline in order to have a spot in the clinic. Clinic goes ahead Rain or Shine! No refunds without Vet/Doctor's certificate.
