### **ACCEPTING BROKEN CONCRETE**

We will accept broken concrete ONLY at our Pit #2 facility (22750 Hassert Blvd /111<sup>th</sup> St.) in Naperville. Beginning in 2014, we will offer recycled concrete (CA-6 and 3 inch) from this facility only.

#### CUSTOMER PROCEDURES:

1. Customers MUST familiarize themselves with Boughton's procedures for accepting broken concrete
2. Customers MUST complete our "Broken Concrete Pre-Screening Form." We would like to receive this form 24 hours PRIOR to you arriving at our facility, however we will accept less. We must verify the source (location and history of site) of the broken concrete and this will involve some amount of time. Depending on our workload, your drivers may sit for a long time while we verify this information if the form is not given to us the day prior. **If you cannot completely fill out this form, we cannot accept your material.**
3. We **DO NOT ACCEPT:** Concrete pipe, landscape material, wood, tree limbs, grass, dirt, bricks, painted concrete, foam, asphalt, clay, or concrete from demolished or remodeled commercial buildings.
4. Upon arrival, contents will be visually inspected by our dispatcher. If paperwork and visual inspection are satisfactory, driver will be told where to dump material.
5. After material is dumped, it will again be visually inspected a second time for compliance with our restrictions on what material can, and cannot, be accepted.
6. If a load is rejected upon presentation of Pre-Screening Form or after initial visual inspection by dispatcher, your truck will be turned away without charge and no further material will be accepted from that site location.
7. If the load is rejected after dumping the material and visually inspected a second time, the operator **WILL BE CHARGED** the appropriate dumping fee and the contents will be reloaded onto the customers' truck for removal. If Boughton must remove the material, the operator will be charged the appropriate dumping fee PLUS ANY AND ALL EXPENSES Boughton incurs to bring the material to a proper disposal facility.
