The BHS is only able to make changes to passports originally issued by the Society. We cannot process any passport issued by another organisation.

The cost of transferring ownership is £15 (or £10 for equine charities); this is exclusive of any postage other than second class mail. Please complete the form in BLOCK CAPITALS and return to the address at the bottom of the form, along with any proof of purchase you have and the horse's passport. Please only send photocopies of receipts as we cannot guarantee they will be returned. We are unable to transfer ownership to children under the age of 16; ownership must be in the parent or quardian's name. If the horse is jointly owned, we do require all owners' signatures to be on this form. Current and new owners of the animal need to sign this form. Please contact the BHS passport office if you have any queries.

Upon receipt of the Change of Ownership form, the BHS will complete the required changes within 10 working days. Fast Track applications cost an additional £25, will be processed within one working day and are only payable by card. Please be aware that incorrect paperwork
