Itinerary. Copy of round trip tickets or itinerary.

Business letter. A **NOTARIZED** business letter from the sending company in Canada. The letter should be one page, printed on company letterhead stationery, addressed to "The Embassy of Saudi Arabia, Visa Section", and signed by a senior manager (an equivalent

to Vice-President or above). The business letter must adhere to the following guidelines:

- Briefly introduce the applicant (please specify employment status/position held in the company by applicant).
- Specify the dates of entry and departure.
- State the nature of the business to be conducted (ie. business meetings, contract negotiations, etc.) and the names and addresses of

companies to be contacted in Saudi Arabia.

- Specify the type and desired validity of the visa (ie. a one year multiple entry business visa).
- Signed and stamped by Canadian Chamber of Commerce or Board of Trade.
- Guarantee of sufficient funds for travel.

The company must also provide a copy of its valid Business Registration Certificate. The letter must also be stamped by the

Ministry of Foreign Affairs in Canada.

Invitation letter. A visa approval notice issued by the Ministry of Foreign Affairs OR an electronic letter of invitation from the company in Saudi Arabia. This letter must be signed and sealed by the company and stamped by the Saudi Chamber of Commerce. The

invitation or approval notice must be addressed to the Saudi Arabian Embassy in Ottawa. **Businesswomen** must submit a visa approval notice issued by the Saudi Ministry of Foreign Affairs.

Business registration certificate. A copy of the valid Business Registration Certificate from the sending company in Canada. If the registration is older than 2 years, please also include one of the following:

- A recent corporate notice of assessment.
- A valid business license.
- A certificate of status/good standing/existance.

Notification to all agents and all applicants. This form is available here.

Inviting Company's Business Registration Certificate. The company in Saudi Arabia must also provide a copy of its valid Business Registration Certificate.

IMPORTANT: The passport MUST contain two blank visa pages side by side in order for the visa to be issued. The Saudi Arabian embassy will only be accepting single entry visas within 30 days of their departure date from Saudi Arabia"
