What is TransParenting?

formerly "Children Coping With Divorce"

It is a four-hour educational program about the needs of children during and after the divorce of their parents. Topics include typical reactions of children, skills that help children cope, visitation issues, and pitfalls to avoid. It is not a counseling session for individual problems. Personal problems and personalities will not be discussed.

Why do I have to attend?

The Circuit Judges of Baldwin County require all divorcing parents to complete this program. It is in the best interest of your children that you take the time to see the divorce through the eyes of your children. You will learn how to help your children through this difficult time.

What if I fail to attend?

The divorce may be delayed if both parties do not attend the complete program as ordered.

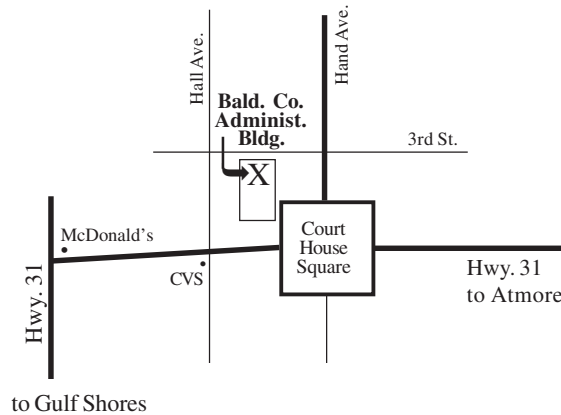

Child Care is not provided. Children are not allowed to attend the program.

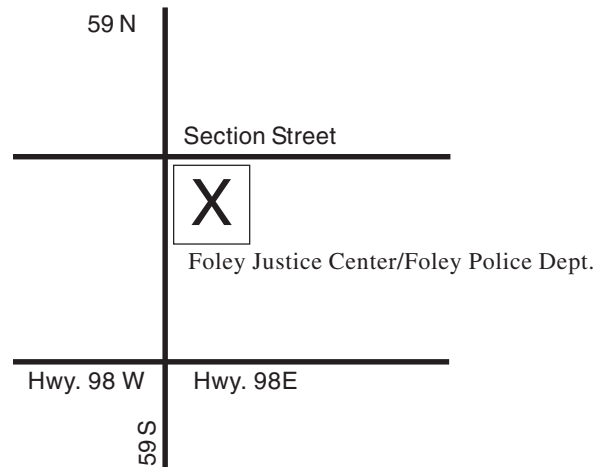

The four-hour course has a short break. No smoking is allowed in the seminar.

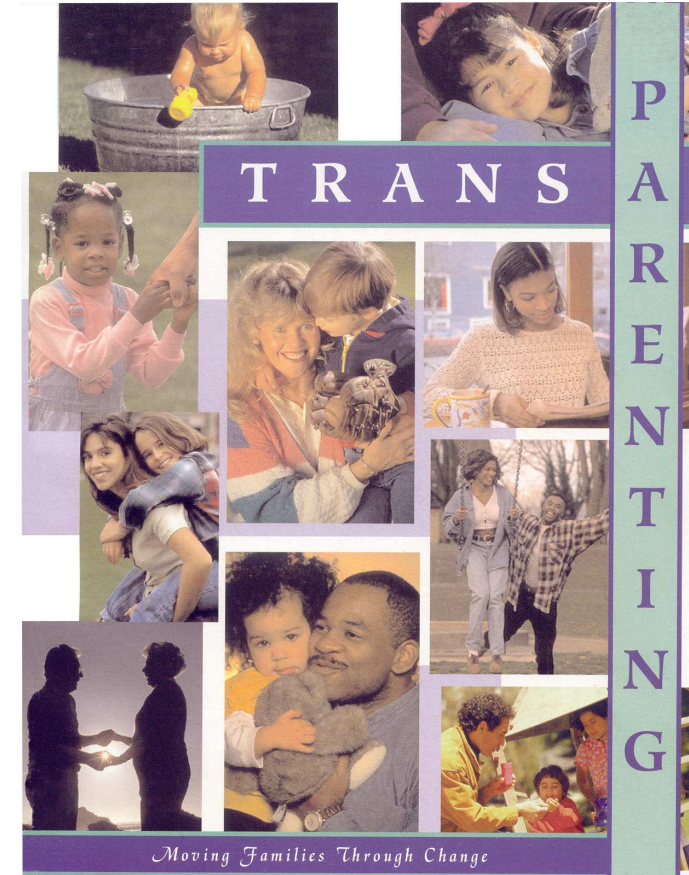
