NOTES:-

1. Membership season runs from 1st March to the end of February each year.
2. New Ordinary Members and/or members changing to Ordinary Membership from a different category may be required to pay an Entrance Fee (not for 2014). (For previous Intermediate Members, entrance fees are subject to a reduction of one quarter for every year completed to a maximum of three quarters of the said Entrance Fee ruling at that time).
3. **Family Membership - £1424.00** covers the entrance fees for both adults and subscription for two adults (Ordinary Membership) and their children (under 18 years old).
4. A bar subscription of £50.00 will be payable for all adult playing members. This will be credited to members swipe cards.
5. Age restrictions relate to age as at **1st March**. For example any girl/boy who attains the age of 10 years after the 1st March 2014 will still maintain Cadet Membership for 2014.
6. VAT is charged at 20%. VAT No: 260 2690 75
7. Fees are due in advance of the membership year. There is the option to pay by credit/debit card (a surcharge applies for credit card payments) or monthly by direct debit through Fairways Credit (this facility incurs a surcharge). Subscriptions payment only may be paid by 2 equal instalments on 1st of March and 1st June.
8. No Proposer and Seconder are currently required.
