### Agreement:

1. This Rent-to-Own Agreement is between TMSL and the Renter for 1 (one) Alpha-Stim® 100, with all accessories and a training DVD, for a period of 9 months or upon termination of this Agreement by Renter returning the Alpha-Stim® 100 to TMSL in excellent condition (including all original packaging, manual and DVD) whichever occurs first. Return shipping costs are Renter's responsibility to TMSL head office address by signed delivery.

2. Payment on this Rent-to-Own Agreement by Renter to TMSL shall be through monthly credit card or debit card billings as follows (please select box which applies):
  - a) **£149.00** in advance with this Agreement prior to shipment which includes a **£99.00** non-refundable deposit and first month's rental payment of **£50.00**. Advance payment should have been made via the website.  
Then **£56.25** per month for months 2 through 9  
**OR**
  - b) **£124.16** advance with this Agreement prior to shipment which includes a **£82.50** non-refundable deposit and first month's rental payment of **£41.66**. Advance payment should have been made via the website, using a discount code to claim VAT relief.  
Then **£46.88** per month for months 2 through 9
  
3. This is a total of:
  - a) **£599.00** for the entire 9 month period, freight charges of **£9.95** would have been received with advance payment as outlined in 2.a during checkout via the website  
**OR**
  - b) **£499.20** for the entire 9 month period, freight charges of **£9.95** would have been received with advance payment as outlined in 2.b during checkout via the website
  
4. During the term of this Agreement, the Alpha-Stim® 100 covered herein remains TMSL property with assurance of TMSL right of recovery with or without process of law. Upon receipt of the final payment the Alpha-Stim® 100 will become the property of Renter. In the event of default of a monthly payment through denial of credit card or debit card payment or other breach, Renter must return the Alpha-Stim® 100 to TMSL without delay. In the event of default or return of the Alpha-Stim® 100 prior to the 9th payment, TMSL may retain all money paid as liquidated damages and rental. Damages to the Alpha-Stim® 100 outside of regular wear and tear become an extra charge to Renter. In the event of litigation, legal and recovery fees shall be added hereto.
  
5. Renter acknowledges that the Alpha-Stim® 100 hereby rented is for the Renter's sole benefit and in the event of loss, damage, theft or destruction of the device, Renter must pay to TMSL the full amounts due as described in paragraph 2 above. Renter agrees to exercise normal care in the handling and operation of the Alpha-Stim® 100. The Alpha-Stim® 100 is warranted for 5 years exclusive of accessories.
  
6. Billing will be done monthly by TMS to Renter's credit card or debit card number as used to make first payment and deposit of **£149.00** or **£124.16** plus postage and packaging through our website as part of the advanced payment.
  
7. It is the Renter's responsibility to inform TMS of any changes to payment details immediately and to ensure funds are available.
