Dear Business Owner/Manager:

You have been invited to participate in our **Christmas Gift & Craft Show** which will be held December 4-6th. The show hours will be Friday 12 - 9pm, Saturday 10am - 9pm & Sunday 12 - 6pm.

This event will feature holiday gifts appealing to all shoppers to include arts & crafts, jewelry, household goods, health & beauty, cooking supplies, apparel & much, much more. This show works exclusively to promote your business to a great number of mall shoppers during this three-day event. The majority of the mall shoppers live in Madison County and the surrounding area communities and should be considered your potential target customers.

The rate is as follows:

10 X 12 Single Booth Space to include one 6' table & 2 chairs = \$75.00 (\$75.00 cash payment will be collected on Friday, 12/4 from mall management prior to 12pm.)

Booth set up time will be Friday, 12/4 8am - 12pm. **Set up must be completed by 12pm.** *Tear down time will be Sunday, 12/6 6pm -11pm

Tear down will not take place until after the show is over at 6:00pm. There are no exceptions to this rule, in order to be a mall vendor you must have your booth open until 6:00pm Sunday.

If you need to rent any additional 6' tables they will each be \$10.00. (Mounds Mall is limited to a number of tables and chairs and will be reserved on a first-come, first-serve basis). Please also understand there is a limited space with electricity available within the mall, therefore, if you need electricity, electric booth spaces will be reserved on a first-come, first-serve basis. Note there will be no additional fee for electric.

Registration deadline is December 1st, 2015. If you are interested in participating, please fill out booth form on reverse side (please make extra copy for your records) and either fax to 765-644-8417, email broosa@moundsmall.com or mail to the Mall Office attn: Braun Roosa. Once we receive all entry forms, we will follow up with vendor confirmations & floor plans with your designated booth space shown. Mounds Mall has the right to limit the number of vendors with similar products-for example, too many jewelry applicants or no more than one Avon vendor, etc.

REMINDER: The \$75.00 booth fee will be collected on Friday, 12/4 prior to 12pm by mall management.
