Mr. Edgington provided Council with an overview of the work done to date on the Governance and Boundaries Project explaining that the methodology will be a four step process that includes the following:

- 1. Problem Definition identification of the problem(s), related issues and key questions
- 2. Desired Outcomes identification of key results if the problems identified are addressed.
- 3. Option Identification and Analysis options for addressing the problems raised and achieving the desired outcomes will be identified and analysed.
- 4. Recommendations: The options which best address the defined problems will be put forward for action along with an action and communication plan for implementation.

Mr. Edgington advised that it is the hope of the Regional District that member municipalities and Areas will have all held a workshop on the issues by April understanding that RMOW and Squamish may be delayed due to the Olympic activities. Mr. Edgington also advised that there is funding available for facilitation for member municipalities.
