TENDER FOR THE SUPPLY AND DELIVERY OF NON CALCIUM, NON ALUMINIUM PHOSPHATE BINDER:

- LANTHANUM BICARBONATE OR
- SEVELAMER BICARBONATE

1. Introduction

1.1 The National Kidney Foundation ("**NKF**") wishes to appoint a contractor (the "**Contractor**") for the supply and delivery of non calcium, non aluminium phosphate binder - Lanthanum bicarbonate or Sevelamer bicarbonate or any equivalent product to NKF as described in these Requirement Specifications (the "**Goods**"), to NKF office in Singapore.

2. Product Specification

2.1 The Goods must be registered with Health Science Authority and shall conform to the detailed specification in **Annex A**.

3. Quantity requirements and delivery schedule

- 3.1 The Contractor shall supply the Goods over a period of **twelve(12) months**, from **January 2016 to December 2016**, subject to such an extension of the period of appointment by NKF in accordance with the Conditions of Contract.
- 3.2 NKF estimates consumption for the Goods over a period of twelve (12) months is set out in the table below:

3.3 The Goods shall be delivered monthly to NKF office located at 81 Kim Keat Road, Singapore 328836.

4. Submission of tender bids

- 4.1 Each Tenderer should provide the price quote in the Price Schedule.
- 4.2 All quotations submitted by the Tenderer must indicate the prices applicable for the estimated numbers of Goods specified in paragraph 3.2 above.

- 4.3 The Tenderer, at the point of submission of its tender bids, is required to supply at its own costs at least two (2) nos of samples for each sample stipulated in its tender bids. The NKF shall be at liberty to call for further submission of such samples as required until the samples submitted are in accordance with the requirements of the Tender. Samples after approval shall indicate the standards to be maintained for the duration of the Contract.
- 4.4 Each tenderer is required to indicate the minimum delivery lead time for the proposed product based on 1 month's quantity in the Price Schedule.
