# Course: Master Exercise Practitioner Program (MEPP) Fiscal Year 2012 Change in Prerequisites

The Emergency Management Institute (EMI) has slightly adjusted the MEPP prerequisites to include selected resident and non-resident (E/B/L) coded and G-coded courses (administered by States and other training providers).

The following Independent Study (IS) requirements can be met with completion of specific courses for the following:
