1.	Application form Dully filled in all blanks in English or Spanish and signed and dated by the applicant himself. If the applicant is under the age of 18, both parents or legal guardian must sign a "Letter of consent"; present original passports and copies and attach a valid birth certificate of the minor. 2.	Original letter from local sponsor · Written in English stating purpose of trip, qualification, salary and start date of employment in the UAE. · If self-sponsor, copy of trade license officially translated into Spanish or English.	
3.	Passport Passport with valid UAE residence visa with a minimum validity of 2 months from the date of expiry of requested visa. Passport validity of 3 months from the date of expiry of requested visa. Passport not older than 10 years, signed by bearer. Undamaged pictures securely affixed with/to passport. Previous passport, if applicable.	
4.	One recent biometric passport sized photographs • Pictures must comply with EU recommendations (can be consulted in this Website) • Should not be older than 6 months.	
5.	Photocopies Passport pages containing personal data and residency visa Previous Schengen, US, UK, Canada, Japan visas.	
6.	Overseas medical insurance. Valid for the duration of the requested visa and all Schengen countries. · Must cover all risks expected during the time of stay in the Schengen area, including repatriation. Minimum coverage is 30,000€ + repatriation. (Medical insurances connected to credit cards are not accepted) · Conditions must be stated either on insurance document or on separate confirmation letter	
7.	Valid visa for final destination.	
8.	Return ticket reservation: If the visa is granted, paid ticket can be requested.	

A transit visa allows visa holders to stay in the international transit area of a Spanish airport, without access to the national territory, during stopovers or flight connections. Entry clearance requirements depend on the citizenship and resident status of the applicant (sometimes in a third country). You must confirm with your travel agent or airline whether your flight is scheduled via another airport. If you leave the airport's international transit area (for instance, if you change the terminal), you will have to apply for a Schengen Visa – Category C.

Third countries whose nationals are required to have an airport transit visa (VTA) in Spain ANGOLA, COTE D'IVOIRE, CUBA, DJIBOUTI, GUINEA-BISSAU, GUINEA CONAKRY, INDIA, LIBERIA, MALI, SIERRA LEONE, SYRIA, TOGO, AFGHANISTAN, BANGLADESH, ERITREA, ETHIOPIA, GHANA, IRAN, IRAQ, NIGERIA, PAKISTAN, DEMOCRATIC REPUBLIC OF CONGO, SOMALIA, SRI LANKA.

VTA is not required to holders of diplomatic, official or service or ordinary passport holders who are residents or holders of a valid entry visa in a Member State of the Agreement on the European Economic Area, in Canada or the United States. VTA is not required for holders of diplomatic, official and service passports, or holders of a residence permit of a European Economic Area country, Andorra, Canada, United States, Japan, Monaco, San Marino and Switzerland.

(In the case of Ghana and Nigeria, VTA is limited to citizens of these countries without a valid visa issued by a Member State of the European Union or a valid visa for a State party to the Agreement on European Economic Area, or to Canada, Japan, United States and Switzerland)
