

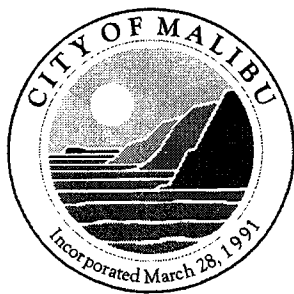

CALL TO ORDER

Chair Saul called the meeting to order at 6:05 p.m.

ROLL CALL

The following persons were recorded in attendance by the Recording Secretary:

PRESENT: Chair David Saul; Vice Chair Chris Frost; and Commissioners Marlene Matlow and Carol Randall

ABSENT: Commissioner Meril May

ALSO PRESENT: Bob Brager, Public Works Director; Arthur Aladjajian, Public Works Superintendent; Lieutenant Jim Royal, Los Angeles County Sheriff's Department Liaison; and Mary Linden, Recording Secretary

PLEDGE OF ALLEGIANCE

Fire Department Battalion Chief Anthony Williams led the Pledge of Allegiance.

APPROVAL OF AGENDA

MOTION Commissioner Randall moved and Chair Saul seconded a motion to approve the agenda. The motion carried 4-0, Commissioner May absent.

REPORT ON POSTING OF AGENDA

Recording Secretary Linden reported that the agenda for the meeting was properly posted on September 24, 2014.

ITEM 1.A. PUBLIC COMMENTS

Graeme Clifford stated he had just learned that Caltrans would conduct paddle repairs along Pacific Coast Highway (PCH) next week. He expressed frustration with how traffic routinely backed up on PCH approaching Topanga. He discussed proposed medical marijuana facilities on PCH and potential safety hazards. He asked for an update on improvements at the intersection of PCH and Las Flores. He stated the closure of Rindge Dam was a safety improvement.

Al Broussard deferred his time to Shea Broussard.

Shea Broussard, a former Malibu resident, stated he lost his home in the 1993 fire. He distributed information about Flamemapper, a web-based software program for wildfire protection strategies and planning. He discussed how the program helped communities to plan for and mitigate fire emergencies.

Chair Saul suggested that Mr. Broussard contact Emergency Services Coordinator Davis.

Commissioner Matlow requested discussion of Flamemapper be added to a future agenda.

#### ITEM 1.B. COMMISSIONER COMMENTS

Commissioner Matlow stated she pulled information together she hoped to submit to the local papers about emergency preparedness. She stated she was going to meet with Emergency Services Coordinator Davis regarding the next steps. She requested a Southern California Edison representative attend a future meeting to discuss lighting on the highway.

Commissioner Randall agreed with Mr. Clifford regarding the need for an adjustment to the timing of the signal at PCH and Topanga Canyon. She agreed with Mr. Clifford regarding improvements needed along PCH at Las Flores and Rambla Pacifico. She stated drivers exiting the gas station near there were confused by the signals.

Vice Chair Frost discussed his participation in the Las Virgenes-Malibu Council of Government's bike count at Trancas on September 27 and 30. He stated approximately 50 percent of cyclists ran the red light on PCH at Trancas on Saturday. He discussed ongoing safety problems with pedestrians crossing the highway near Corral Canyon. He suggested the City work on finding a permanent solution. He commended the City's work on PCH at Trancas and Morning View. He asked for an update on the valet ordinance.

#### ITEM 2 CONSENT CALENDAR

MOTION Commissioner Matlow moved and Vice Chair Frost seconded a motion to approve the Consent Calendar.

Commissioner Randall requested the motion for Item No. 4.B. on page 6 of the minutes from the September 3, 2014 Regular meeting be corrected to state that the signage requested was to prohibit exiting onto PCH and directing traffic to utilize the Trancas Canyon exit from the shopping center.

The question was called and the motion carried 4-0, as amended, Commissioner May absent.

The Consent Calendar consisted of the following items:

ITEM 4 NEW BUSINESS

Item Nos. 4.A. and 4.B. were heard concurrently.

A. Public Safety Agencies Annual Service Review

Staff recommendation: Develop Discuss recent Public Safety Agency activities and receive and file monthly activity reports from the County of Los Angeles Sheriff's Department, Fire Department and Lifeguard Division.

B. Public Safety Agency Activity

Staff recommendation: Discuss recent Public Safety Agency activities and receive and file monthly activity reports from the County of Los Angeles Sheriff's Department, Fire Department and Lifeguard Division.

Recording Secretary Linden introduced Los Angeles County Sheriff's Department Captain Patrick Davoren, Los Angeles County Fire Department Battalion Chief Anthony Williams and Community Services Liaison Maria Grycan, and Los Angeles County Fire Department Lifeguard Section Chief Fernando Boiteux.

Community Services Liaison Grycan presented the Fire Department's report. She recommended Pulse Point, a cellphone app that could notify the phone owner of someone nearby who was in need of CPR, so lifesaving efforts could be in process before paramedics arrived. Battalion Chief Williams discussed augmented staffing in Malibu for the Red Flag Warning in effect at least through tomorrow.

In response to Commissioner Matlow, Community Services Liaison Grycan stated the Fire Department could come to a home or community gathering to teach groups CPR. Commissioner Matlow discussed NextDoorPointDume.com. She discussed the concerns many people had for the health and safety of pets and children due to numerous fireworks displays off the Malibu coast. In response to

Commissioner Matlow, Community Services Liaison Grycan stated the Fire Department was going to discuss policy and procedures regarding fireworks permits with the City Manager. She stated the community's concerns would be taken into consideration in amending the policy.

In response to Commissioner Matlow, Community Services Liaison Grycan stated the Fire Department could not set a limit for the number of fireworks displays permitted.

Chair Saul stated the major problem with the most recent fireworks show was that it was allowed to start earlier than the original time on the permit, which had been communicated to the community. In response to Commissioner Matlow, Community Services Liaison Grycan confirmed a Fire Department representative was required to be in attendance at the location to which a fireworks permit was issued.

Commissioner Matlow asked how Fire Department personnel got to people in need in Paradise Cove during congested summer months.

Chair Saul thanked all the public safety agencies for the services they provide to the City. He commended firefighters for their professionalism. Community Services Liaison Grycan stated the firefighters wanted to work in Malibu.

Lifeguard Section Chief Boiteux stated 2014 was a very busy year. He stated there had been over 4,000 rescues already in 2014 and beach attendance was on track for a 30-year record. In response to Chair Saul, Chief Boiteux stated staffing was steady, the budget was strong, and staffing was not expected to be reduced.

Commissioner Randall discussed an inexperienced surfer who lost his life in the recent high surf conditions. In response to Commissioner Randall, Chief Boiteux explained how the tide changed the ocean floor and resulting tide changes.

Lt. Royal stated the Beach Team and Lifeguards worked very well together this summer. Battalion Chief Williams and Lt. Royal discussed how the Fire Department and Sheriff's Department were preparing for the high fire danger this weekend and throughout the fire season.

Vice Chair Frost left the meeting at 6:58 p.m.

Lt. Royal stated the Lost Hills Station was on NextDoor.com at Captain Davoren's request. Captain Davoren stated it was the future of community policing.



C. 2014 Summer Beach Enforcement Operation Summary

Staff recommendation: Receive and file summary report of the 2014 Summer Beach Enforcement Operation.

Lt. Royal presented the report. He stated the 2014 Beach Team was a success. He discussed increased parking control and enforcement on the busy weekends. He commended the Beach Team for its dedication and introduced Tuyet Alcala, a parking control officer. He discussed a 10-year statistical review of collisions he conducted. He stated the numbers had not drastically increased, but may seem so because the information was more available to the public. He stated heightened awareness of PCH traffic safety and stronger enforcement by the Sheriff's Department could be factors in keeping collision numbers from increasing.

Vice Chair Frost returned to the dais at 7:06 p.m.

Commissioner Matlow complimented Lt. Royal for doing an excellent job for the community and for the Commission. She requested Captain Davoren authorize a traffic sergeant or traffic expert to attend future Commission meetings to address specific traffic enforcement issues. Commissioner Randall agreed with Commissioner Matlow and added that the Commission was still interested in having the Sheriff's Department work with the City to get safety educational information to the local media.

At the request of Commissioner Randall, Chair Saul re-opened Item No. 4.B.

B. Public Safety Agency Activity (continued)

Commissioner Randall questioned why there were no bicycle-related citations in the Sheriff's report, despite numerous infractions being observed, including riding through stop signs and red lights.

Captain Davoren stated the Sheriff's Department was meeting regularly with representatives of the Los Angeles County Bicycle Coalition.

Lt. Royal discussed different interpretations of the vehicle code for when bicyclists could take a lane. Commissioner Randall stated PCH was often relegated to a two-lane highway on busy weekends when groups of cyclists took a lane for the length of the highway. Captain Davoren stated deputies would be instructed to step up enforcement, especially for bikes running through stop signs and red lights.

D. Update on Projects Affecting Traffic on Pacific Coast Highway (PCH) and City Streets

Staff recommendation: 1) Receive and file status updates on projects affecting traffic on PCH and City streets, including: a) PCH and Kanan Dume Road Intersection and Arrester Bed Improvements Project; b) PCH Bike Route Improvement Project; c) Fiscal Year 2014-2015 Street Maintenance; d) PCH Seawall Project near Las Tunas State Beach; e) Bus Stop Enhancements; f) Caltrans maintenance work; and 2) provide questions to be asked during the City's biweekly conference call with Caltrans staff.

Don Schmitz discussed his work with Caltrans on intersection improvements at PCH at Webb Way and PCH at Cross Creek Road as part of his La Paz project. He explained that a right turn lane would be added, the left turn pocket deepened and a bike lane added. He stated all improvements would be in the public right of way and no parking would be removed.

In response to Chair Saul, Public Works Director Brager stated the draft speed survey had been reviewed by the traffic engineer and would be presented to the Commission for review at its November 5, 2014 meeting. In response to Chair Saul, Public Works Director Brager stated staff was actively researching other cities' valet ordinances. In response to Vice Chair Frost, Public Works Superintendent Aladjadjian confirmed the ordinance would apply to all valets operating on PCH. Vice Chair Frost suggested staff look at OSHA requirements for road workers.

In response to Chair Saul, Sheik Moinuddin, Caltrans Senior Traffic Engineer, stated the revised plan for the right turn lane at the Trancas shopping center had not yet been received from the developer. Omid Ghaemi, Acting Chief for the Caltrans Office of Permits, stated the application had been inactive for approximately six months. Chair Saul asked why Caltrans could not just do the work. He asked if Caltrans had suggestions for making the safety improvements at Trancas happen sooner. Mr. Ghaemi agreed with Chair Saul's assessment of the situation, but stated there was a right of way dedication involved that limited Caltrans' options. He stated it should be a collaborative effort. He stated Caltrans would pursue the property owner more aggressively and more assertively to make it happen. He stated Caltrans was not in a good position due to right of way limitations. Vice Chair Frost stated someone from Caltrans needs to phone the developer.

Graeme Clifford requested an update on any remedial work planned for the intersection at PCH and Las Flores Canyon. Mr. Moinuddin stated Caltrans would have to work with the City to develop a design to correct the problems. He stated the close proximity of the two signals at Las Flores and Rambla Pacifico presented problems for resolving the safety issues.

Public Works Director Brager agreed that the Las Flores intersection was the most dangerous intersection in the City. He discussed the City's process for making safety improvements in that area. He stated Measure R funds were designated for improvements at that location.

Commissioner Randall asked if there was anything planned to alleviate the traffic bottleneck at PCH and Cross Creek Road. Mr. Ghaemi discussed mitigation measures included in the La Paz project. Don Schmitz discussed specific changes to be implemented, including widening the lanes to full, standard width, that were included in the environmental impact report. He discussed the need to remove a sycamore tree. He requested the commissioners express their support for the project to the Planning Commission.

#### ADJOURNMENT

MOTION At 8:26 p.m., Vice Chair Frost moved and Commissioner Matlow seconded a motion to adjourn. The motion carried 4-0, Commissioner May absent.

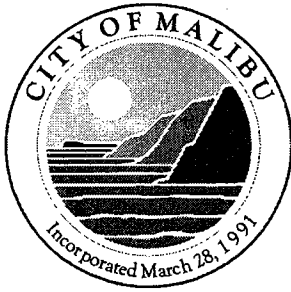

**RECOMMENDED ACTION:** 1) Review the Speed Survey Recommendations from the Draft 2014 Engineering and Traffic Survey to Establish Speed Limits (Speed Survey); and 2) make a recommendation to the City Council that it adopt the Speed Survey and implement its speed limit recommendations.

**DISCUSSION:** The Speed Survey is intended to serve as the basis for the establishment and enforcement of speed limits for street segments within the City of Malibu.

Speed surveys are required by Section 40802(a) of the California Vehicle Code (CVC) and the national Uniform Vehicle Code in order to enforce speed limits by radar. State law requires speed zones to be evaluated on a regular basis to ensure that the posted speed limits are justified for the road conditions. Under CVC Sections 627 and 40802, engineering and traffic surveys that are older than 7 years can result in challenges of evidence of speeding that is obtained by radar.

Since the most recent Engineering and Traffic Survey for the City was conducted in 2007, a new survey has been prepared in order to continue radar enforcement of speed limit violations through the utilization of current data.

The Speed Survey includes the review and analysis of 40 road segments within the City limits and was conducted in accordance with the CVC. The survey includes field observations and an inventory of road geometrics, review of accident data, evaluation of surrounding land use, roadway crossings and other relevant information, such as roadway and roadside conditions that may contribute to special circumstances. The location and

presence of existing speed limit signs were also reviewed and documented. Additionally, traffic counts were conducted for each road segment.

Within the Speed Survey, Table 3: Speed Survey Recommendations (attached) summarizes observations and data for the 40 City road segments and includes the recommendation of 3 changes to speed limits within the City:

SEGMENT NO.	SEGMENT LOCATION	EXISTING (POSTED) SPEED LIMIT	PROPOSED SPEED LIMIT
1	Big Rock Drive between Cool Oak Way and Pacific Coast Highway	30 miles per hour (MPH)	25 MPH

8	Carbon Canyon Road between Carbon Mesa and Pacific Coast Highway	30 MPH	25 MPH

For Segment Nos. 1, 7, and 8, the speed limit is recommended to be decreased by 5 miles per hour (MPH) from the posted speed limit based on the 85<sup>th</sup> percentile speed and the accident history for each segment. All others segments in the study are proposed to remain unchanged from the current posted speed limits as noted in the report.

It is important to note that the Speed Survey does not include Pacific Coast Highway as it is owned, maintained and regulated by the State of California. The Speed Survey also does not include any private roads within the City limits.

Staff intends to recommend to the City Council that the speed limit recommendations in the report be adopted. Staff suggests the Commission make a recommendation to the City Council that it adopt the Speed Survey and implement the speed limit recommendations. The Commission's recommendations will be included in staff's City Council agenda report.

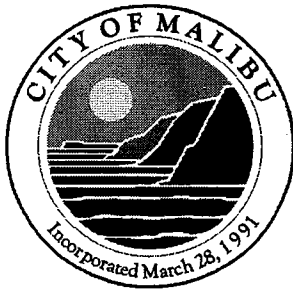

Subject: Update on Projects Affecting Traffic on Pacific Coast Highway (PCH) and City Streets

---

**RECOMMENDED ACTION:** 1) Receive and file status updates on projects affecting traffic on PCH and City streets, including: a) PCH and Kanan Dume Road Intersection and Arrester Bed Improvements Project; b) PCH Bike Route Improvement Project; c) Fiscal Year 2014-2015 Street Maintenance; d) Bus Stop Enhancements; e) Caltrans maintenance work; and 2) provide questions to be asked during the City's biweekly conference call with Caltrans staff.

**DISCUSSION:** Below are the latest updates on the status of projects in and around Malibu that affect traffic and public safety on PCH and City streets:

- a) PCH and Kanan Dume Road Intersection and Arrester Bed Improvements Project – The additional signage to enhance the new arrester bed improvements is scheduled to be installed and completed by middle of November. The truck escape lane is currently open.
- b) PCH Bike Route Improvement Project –The contractor continues to work on the bike lane shoulder improvements along the southbound shoulder of PCH between Morning View Drive and Busch Drive. The striping contractor has removed the existing edge striping within the project limits and installed temporary striping until the shoulder work is completed. Once the shoulder work is complete, the striping contractor will install the permanent edge striping and bike lane. The project is expected to be completed by December.
- c) Fiscal Year 2014-2015 Street Maintenance Project – On Thursday, October 23, 2014, a preconstruction meeting was conducted with the contractor to discuss scope of

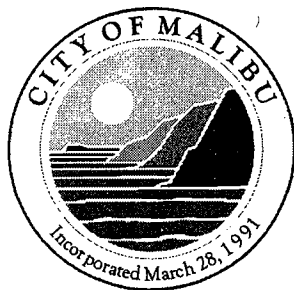
work, traffic control, scheduling, etc. Work includes pavement repairs and asphalt overlay on sections of Latigo Canyon Road and Corral Canyon Road, and slurry seal on Rambla Vista Road. Since the lowest bid is significantly lower than the total budget, the City Council approved additional funding to increase the project's scope of work to include additional pavement repairs and/or asphalt overlay.

- d) Bus Stop Enhancements – Caltrans provided comments on the submitted plans by the City. Once the comments are addressed, the City will resubmit to Caltrans for their review and approval.
- e) Caltrans Maintenance Work – According to Caltrans, they cleared vegetation around catch basins, cleaned inlets, and replaced center median paddles within City limits, including pothole repair near Big Rock area of PCH.

The Commission may provide staff with a list of questions to be asked during the City's biweekly conference call with Caltrans. Responses to those questions will be reported back to the Commission at its next regular meeting. There were no questions submitted during the October 1, 2014 Commission meeting.

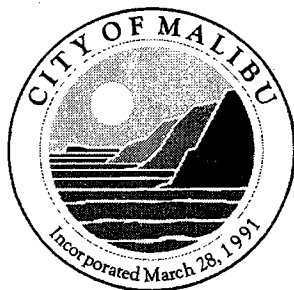
The Fire Department has confirmed that, effective immediately, all permits issued for fireworks shows in Malibu will stipulate that shows can start anywhere between 8:30 p.m. and 9:30 p.m. and that all shows must be concluded by 10:00 p.m.

Notifications of permits approved will continue to be forwarded to the City and, while that notification may include the proposed start time of the show, the City's notification to residents should prepare them that the show can start anywhere between 8:30 p.m. and 9:30 p.m., and will be concluded no later than 10:00 p.m.

The City Council may consider at a future date whether to impose further restrictions, such as establishing a maximum annual number of shows, City permit requirements, etc. If the City does adopt new restrictions, the Fire Department has agreed to adjust its policies to adhere to City ordinances.

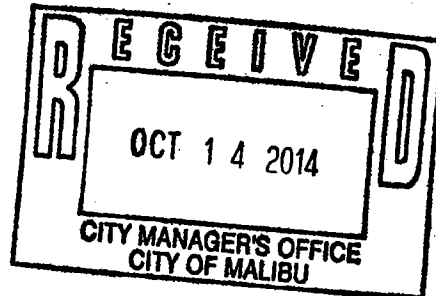



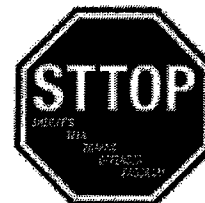

## Community Crime Prevention Tips

### HALLOWEEN SAFETY POINTERS FOR PARENTS

*Halloween may be a fun holiday for kids, but for parents, trick-or-treat time can be a little tricky. Concerns about children's safety — whether they are out in the neighborhood or back home with bountiful bags of goodies — can darken the day more quickly than a black cat. But not to worry! Following a few Halloween safety tips will be a "howling" good time for all.*

#### **MAKE SURE YOUR KIDS DRESS UP SAFELY**

- ▶ Check that the costumes are flame-retardant so the little ones aren't in danger near Burning jack-o-lanterns and other fire hazards.
- ▶ Keep costumes short to prevent trips, falls, and other bumps in the night.
- ▶ Try make-up instead of a mask. Masks can be hot and uncomfortable and, more importantly, they can obstruct a child's vision — a dangerous thing when kids are crossing streets and going up and down steps.
- ▶ Make sure kids wear light colors or put reflective tape on their costumes.
- ▶ Trick-or-treaters always should be in groups so they

aren't a tempting target for real-life goblins. Parents should accompany young children.

#### **MAKE TRICK-OR-TREATING TROUBLE FREE**

- ▶ Make sure older kids trick-or-treat with friends. Together, map out a safe route so parents know where they'll be. Tell them to stop only at familiar homes where the outside lights are on.
- ▶ Try to get your kids to trick-or-treat while it's still light out. If it's dark, make sure someone has a flashlight and pick well-lighted streets.
- ▶ Make sure kids know not to enter strangers' cars.

## ***Consider this***

*Parents and kids can avoid trick-or-treating troubles entirely by organizing a Halloween costume party with treats, games, contests, music, scary stories, and much more. Make your Halloween party the place to be! Schools, fire stations, libraries, or civic groups in many communities organize "haunted houses" and other festivities for families.*

## **TREATS**

- ▶ Kids need to know not to eat their treats until they get home. One way to keep trick-or-treaters from digging in while they're still out is to feed them a meal or substantial snack beforehand.
- ▶ Check out all treats at home in a well-lighted place.
- ▶ What to eat? Only unopened candies and other treats that are in original wrappers. Don't forget to inspect fruit and homemade goodies for anything suspicious. By all means, remind kids not to eat every-thing at once or they'll be feeling pretty ghoulish for awhile.

*Halloween can be a lot of fun for parents and kids alike — if everybody remembers the tricks and the treats of playing it safe.*

## **DRESSED UP AND DANGEROUS?**

Halloween blood and gore are harmless stuff for the most part. Even fake knives, swords, guns, and other costume accessories can hurt people. If these objects are part of a child's costume, make sure they are made from cardboard or other flexible materials. **SCHOOL ISSUES**

We attended 4 hours of CPR training.

We attended 4 hours of At Risk Student Identification Training sponsored by JRIC.

We addressed the Chatsworth Office of D.C.F.S. re: L.A.S.D. procedures and communication.

**INTERVENTIONS**

There were no interventions held in Malibu this month.

**C. COMMUNITY / CRIMINAL ISSUES**

1. We conducted a monthly parental resource class at Lost Hills Sheriff's Station. This program was developed by our unit and is designed to educate parents about: 1) The current trends in juvenile behavior and delinquency, 2) Alcohol/narcotic awareness and recognition, 3) School policy and campus issues, 4) Gang awareness and negative peer relations, 5) Parental rights and responsibilities and, 6) Parental responses to incorrigible and/or delinquent behavior. We also address the specific concerns relating to the minor's behavior. We educate the minor and their parents of possible criminal behavior and the legal consequences. We offer suggestions and make recommendations to improve the minor's quality of life.
2. Spoke with numerous citizens and parents who called to question various juvenile concerns and issues in the community. We also provide the parents with various juvenile resource programs within our community.
3. We met with the Sylmar Juvenile Court District Attorney regarding the investigation and filing of criminal charges against juvenile offenders.
4. Met with Captain Pat Davoren throughout the month in order to keep him up to date regarding our units investigations and current juvenile issues within our city.
5. Entered juveniles into the Juvenile Automated Index system for various violations.
6. Made court appearances to testify as witnesses on the part of the People of the State of California and attended court proceedings in cases generated from the City of Malibu. We also investigated, prepared, and filed cases with the District Attorney's office. We additionally assisted other investigators in the preparation of cases for court.

7. We met with station narcotic detectives on a regular basis to exchange information regarding juvenile and drug related issues. We have worked with the narcotic detectives on several narcotic cases directly and indirectly involving juveniles.
8. Handled the processing and follow-up of various juvenile referrals brought to the attention of this unit (i.e., Juvenile Information Forms, Field Interview Cards, Juvenile Automated Index, and citations for various juvenile contacts with uniform personnel).
9. Conducted our normal checks of juvenile problem areas in the city during weekend evenings and responded to juvenile related calls for service.
10. The Juvenile Intervention Team assisted the COPS Team with Parole Compliance checks in Malibu, Topanga, Calabasas and Westlake Village.
11. Updated the Gang Book and briefed the captain on criminal activity trends.
12. Assisted patrol with the booking of a Malibu High student possessing pot.
13. Drug tested a Malibu High student in our office.

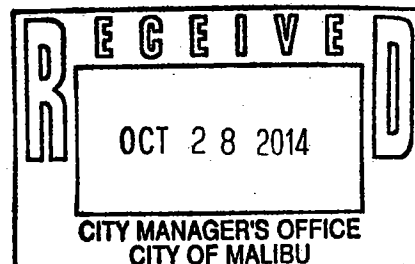

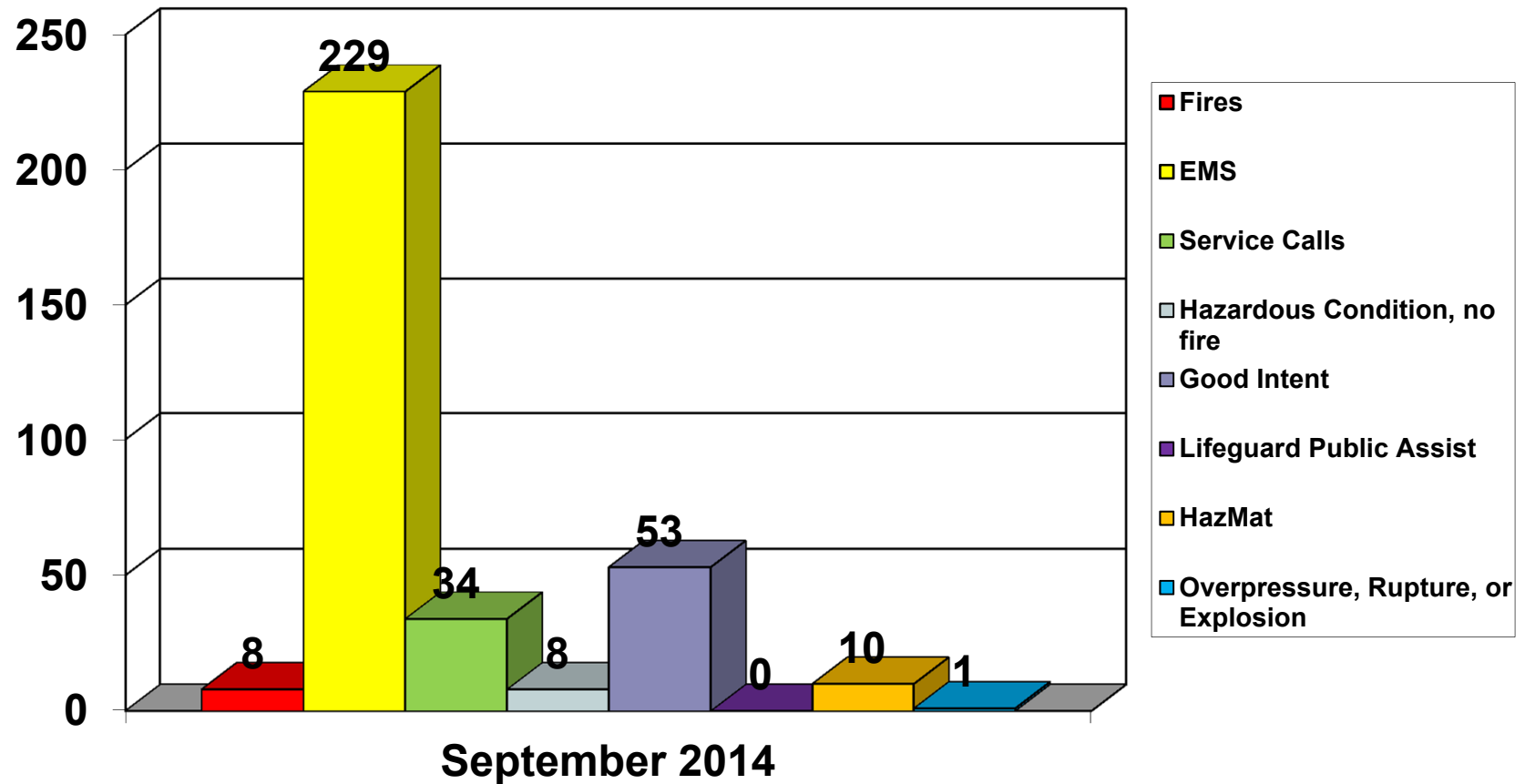

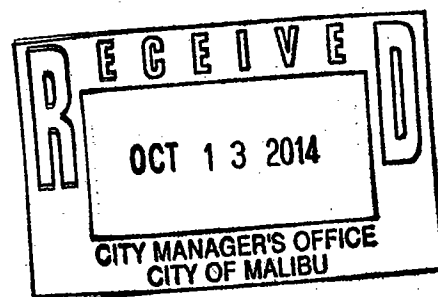
