22 Significant Program Accomplishments

Maximum Characters: 2000

The County of Los Angeles administered the Homelessness Prevention and Rapid Re-housing Program (HPRP) and utilized subrecipients who provided case management, financial assistance, legal services, and data collection and evaluation services. County Departments such as the Departments of Public and Social Services, Community and Senior Services, and Consumer Affairs, and local community based organizations including People Assisting the Homeless, Union Station Homeless Services, and Volunteers of America, Los Angeles, provided assistance to individuals and families that did not have the ability to sustain themselves. This included those who were newly employed, unemployed, and those who had work hours reduced or cut. Others who were also assisted included individuals or families that exceeded CALWorks program requirements.

The rate of persons served steadily increased to a total unduplicated count of 3,400 persons, including 203 veterans, who received Housing Relocation and Stabilization Services and Financial Assistance during the 2010-2011 Program Year ending September 30, 2011.

The County's program met the 60% expenditure deadline in advance of the program requirement and has expended over 80% of its HPRP funds. We began efforts that concentrated on ramping down services. The County closed its online Pre-Screening tool located at (http://housing.lacounty.gov/) to the public, and the Los Angeles County Housing Resource Center was limited to providing links to other resources available for those still seeking HPRP assistance. The Los Angeles Homeless Services Authority (LAHSA) assisted all participating agencies in reconciling grant-to-date HPRP data as each activity prepared to discontinue providing services.

Homelessness Prevention

Under the Homelessness Prevention category, 2,317 persons in 869 households received Housing Relocation and Stabilization Services and case management. Of the total persons served, 2,228 persons in 838 households, demonstrated imminent need to avoid homelessness and who gained housing stability with various financial assistance. The rate of persons leaving the program steadily increased during the program year to a total unduplicated count of 2,003 persons during the period of October 1, 2010 through September 30, 2011. A majority of the persons, 1,954 or 98% of the persons leaving the program, were moving to permanent destinations. Of the total persons moving to permanent destinations, 1,880 were moving to rentals with no housing subsidy.

Rapid Re-Housing

Maximum Characters: 2000

The Los Angeles County Departments of Public and Social Services, Community and Senior Services and Consumer Affairs, and local community based organizations provided assistance to individuals, especially families and youth transitioning from foster care, to assist in rapidly rehousing them into permanent housing. The program provided case management, outreach and engagement, housing search and placement, budget counseling and credit repair, and legal services. A total number of 784 households comprised of 1,098 persons received Housing Relocation and Stabilization Services, including 483 households comprised of 777 persons who received financial assistance. The rate of persons leaving the program steadily increased to a total unduplicated count of 990 persons during October 1, 2010 through September 30, 2011. The majority, 685 or 69% of the persons leaving the program, were moving to permanent destinations. Of the total persons moving to permanent destinations, 465 of the persons were moving to rentals with no housing subsidy.

LAHSA is the lead agency for the Los Angeles Continuum of Care (CoC), which is comprised of the County of Los Angeles, but excludes the cities of Glendale, Long Beach and Pasadena. The Community Development Commission (CDC) collaborated with County Departments, nonprofit community based organizations, and LAHSA to ensure that all HPRP activities complemented the needs identified in the County's CoC. HPRP grant funds were used for financial assistance and housing relocation/stabilization services that were consistent with the CoC, and all services funded with HPRP grant funds addressed the applicable needs identified in the CoC. The County will continue to address homelessness prevention needs through activities implemented with Emergency Solutions Grant funds.

In addition to the CoC, the County's Consolidated Plan identifies programs such as the Los Angeles County Homeless Prevention Initiative that provides \$15.4 million in funding for ongoing prevention programs and \$80 million in one-time funding for innovative prevention programs. HPRP activities complemented the goals identified under the Los Angeles County Homeless Prevention Initiative.

Collaboration with other ARRA programs

Maximum Characters: 2000

The HPRP is not utilized in conjunction with other American Recovery and Reinvestment Act (ARRA) programs but augmented the use of other local resources, including the Veterans Affairs Supportive Housing (HUD-VASH) and CALWorks programs. The Housing Authority of the County of Los Angeles (HACoLA), working with the VA Greater Los Angeles Healthcare System, currently has an allocation of 505 VASH vouchers, provided through the 2009 Omnibus Appropriations Act. In July 2011, HACoLA was allocated an additional 100 Tenant Based Vouchers and 50 Project Based Vouchers for \$868,000. As of September 30, 2011, a total of 308 vouchers were leased.

In March 2011, HACoLA executed an inter-jurisdiction agreement with the Housing Authority of the City of Los Angeles (HACLA), allowing each Housing Authority the ability to administer its VASH program within the other's jurisdiction. Additionally, an inter-jurisdiction agreement was executed with the City of Inglewood Housing Authority allowing HACoLA to administer its VASH Project Based Voucher program within Inglewood's jurisdiction.

Barriers to and challenges with effective implementation

Maximum Characters: 2000

During the first program year, the County experienced several barriers and challenges to effective program implementation and expenditure including realizing the initial program design was too restrictive. Throughout the second program year, the County looked critically at program implementation, expanded service areas, and contracted with additional subrecipients to broaden services and encouraged additionally assisting the literally homeless to increase eligible clientele. These changes resulted in funds disbursement more than doubling from the first program year to the second program year, and the County met its 60% expenditure rate requirement prior to the HUD-mandated deadline.

Grantee's process for oversight and monitoring of subgrantees/contractors

The CDC conducted monitoring reviews of all County HPRP-funded activities since the start of the program. Using an In-Progress Monitoring approach enabled identification of any deficiencies immediately and allowed the subrecipients an opportunity to implement required corrective actions as needed. Each subrecipient was provided a monitoring plan, checklist, and schedule. Programmatic and financial monitoring staff conducted monthly desktop reviews of each activity to ensure milestones and goals were being achieved and reviewed monthly drawdown of HPRP funds and overall expenditures tracking to ensure appropriate pacing with contract expenditure requirements. Monitoring staff conducted on-site reviews at 2-3 month intervals to review client files and ensure eligibility requirements were being met and the proper source documentation was being collected. Monitoring staff and LAHSA data analysts also ensured each subrecipient was entering beneficiary data into the Homeless Management Information System (HMIS) in a timely and accurate manner, that the information was secure, and that each subrecipient was properly submitting quarterly performance reports. Monitoring staff provided comprehensive technical assistance to subrecipient staff throughout program implementation.
