ENTRY

The purpose of this show is to celebrate our common passion for watercolor and water media. In order to encourage the greatest participation in our membership show, jpegs are NOT required for entry. (Award winners will still be required to submit jpegs for publicity purposes) Open to all current members of WWG. To become a member, download membership form at waterloowatercolor.org.

Entry Fee: \$20 check made out to WWG, accompanied by completed entry form. *Each member may submit 1 painting, width limited to 40 inches, no limit on height. Our venue cannot hang more than 50 paintings.* **Medium:** Water media on paper or yupo only. Hand painted collage allowed up to 20% of piece. **Size:** Width limited to 40 inches. No limit on height. **Framing:** undecorated metal or wood, no wider than 2 inches. **Acrylic glazing** only for any frame over 11x14. **Matting required:** White, cream or off white. Colored liner is allowed. **Hangers:** wire only, no sawtooth. **Content:** Must be original in concept, not previously exhibited in a WWG Spring or Fall show. Work may not have been painted in a workshop or under supervision. *No nudes or questionable subject matter.*

Sales: handled by artist. Donation of 20% to WWG.
