Restoration of a Company

Important Information

CIPC introduced legislation on 1 November 2012 which makes the restoration of a company or CC complex and difficult.

- If the company is dormant and has not conducted any business it is cheaper and quicker to register a new company than to restore a deregistered company or CC. (we can register a new company for your in 3-4 weeks)
- However, if the company owns any fixed property, the property cannot be sold (or bought) until the company has been restored and all the annual returns have paid up. This is a time consuming and costly process (up to a few thousand Rand).

Restoring a Company or CC

Step 1:

The following documentation is required by CIPC:

- 1. Certified ID copies of each director/member.
- 2. A Multiple Deed search (reflecting if the company owns a fixed property or not in all the provinces of RSA) http://www.windeed.co.za/spider/ (Note we can provide this service for R200)
- 3. If the company <u>does</u> own fixed property, a letter from National Treasury (restorations@treasury.gov.za or 012-315 5111) and the Department of Public Works (andre.meyering@dpw.gov.za or 012-337 2147) indicating that they do not have any objection to the reinstatement is required.
- 4. **Proof of an advertisement** placed in a local newspaper giving 21 days notice of the proposed application of reinstatement. CIPC require the full page reflecting the date and name of the newspaper. [Sample wording below]
 - Please take notice that (name of member) intends making application to the Commissioner of CIPC for the reinstatement of (Name & Registration number of the company) Please take notice that any objection to the application must be lodged with the Commissioner of CIPC within twenty one (21) days of the date of the publication hereof
- 5. An **affidavit** indicating the reasons for the non-filing of the annual returns (if the deregistration was due to non-payment of annual returns) or an affidavit indicating the reason if the original deregistration of the company was that company itself applied for the deregistration.

- 6. Sufficient documentary proof indicating that the company was in business <u>after</u> the time of deregistration. Eg. *Bank statements, financials (P&L) or other documentary proof.*
- 7. Completed Limited Power of Attorney (last page) which must have original signatures

Step 2.

- Once we have received all of the above information, we will submit the application to CIPC who
 will then unlock the company. This will allow us to access the company profile online and
 determine the amount of outstanding annual returns which are due.
- We will inform you of the amount due to CIPC to which we add our service fee of R150.
- When we have received proof of payment of this amount we will proceed with the completion of the outstanding annual returns and restore the company status from 'deregistered 'to 'in business'.
