TERMS AND CONDITIONS

1. **Application for Delegate Registration**

Sponsors & Advertisers are expected to comply with the venue location policies and regulations and any and all Government rules and regulations including chargeable fees. 2. **Payment**

A further payment of 30% of the total charge is due 30 days after the first payment. Invoices will be submitted and all payments must be made in UAE Dirhams or US Dollars by wire transfer or by cheques payable locally.

3. **Cancellation**
